WHEREAS, Winnebago County is authorized under § 114.136, Wis Stats, to adopt rules and regulations for regulating, restricting, and determining the use, location, height, number of stories, and size of buildings, structures, and objects of natural grown in the vicinity of Wittman Regional Airport; and

WHEREAS, said rules and regulations are currently located in Section 17.24 of the General Code of
Winnebago County; and

WHEREAS, under § 114.136(2)(a), Wis Stats, the Winnebago County Park Director is authorized to formulate a tentative ordinance and hold a public hearing regarding same; and

WHEREAS, the City of Oshkosh, Town of Algoma, Town of Black Wolf, and Town of Nekimi are the areas affected by the proposed ordinance; and

WHEREAS, on February 2, 2012, the Winnebago County Parks Director conducted a public hearing at the
Winnebago County Courthouse to gather public input regarding the proposed ordinance; and
Winnebago County Courthouse to gather public input regarding the proposed ordinance; and

WHEREAS, after the February 2, 2012, public hearing, the Winnebago County Parks Director amended the 36 proposed ordinance as he considered appropriate; and

WHEREAS, the Winnebago County Parks Director and the Winnebago County Zoning Director believe that it will be beneficial to residents of Winnebago County to adopt Chapter 24 of the General Code of Winnebago County entitled "Wittman Regional Airport Zoning Code" and repeal all similar or conflicting provisions in Chapter 17 of the General Code of Winnebago County.
