

2 **RESOLUTION: Establish Salaries for Constitutional Offices**  
3 **of Winnebago County**

5  
6 **TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**  
7

8 **WHEREAS**, § 59.22, Wis Stats, requires that compensation for certain elected county officials be  
9 established by the County Board of Supervisors “. . .before the earliest time for filing nomination papers for such  
10 elected office”; and  
11

12 **WHEREAS**, nomination papers for the offices of Winnebago County Clerk, Winnebago County Register of  
13 Deeds, and Winnebago County Treasurer may be filed beginning April 15, 2012; and  
14

15 **WHEREAS**, it is incumbent that salaries for said constitutional offices be established by the Winnebago  
16 County Board of Supervisors; and  
17

18 **WHEREAS**, the Personnel and Finance Committee of the Winnebago County Board of Supervisors has  
19 recommended that the salaries for said elected officials be established in the form of a straight salary, and that said  
20 salaries incorporate a 1% increase in compensation for the 2013 calendar year; a 1.5% increase for the 2014  
21 calendar year; and a 2% increase for the 2015 and 2016 calendar years; and

23 **WHEREAS**, the Personnel and Finance Committee has also recommended that said elected officials be  
24 eligible for and may elect to receive fringe benefits, specifically, health insurance through Winnebago County’s group  
25 health insurance plan under the same terms and conditions as is provided for full-time appointed department head  
26 employees of Winnebago County; and

28 **WHEREAS**, the Personnel and Finance Committee has also recommended that said officials be entitled to  
29 participate in the Wisconsin Retirement System and pay their share of total Wisconsin Retirement System  
30 contributions as is required by state Statute.

33 **NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of Supervisors that it hereby  
34 establishes the total annual compensation for the elected offices of County Clerk, County Treasurer, and Register of  
35 Deeds as follows:

38 **BE IT FURTHER RESOLVED** by the Winnebago County Board of Supervisors that each elected official is  
39 entitled to participate in the Wisconsin Retirement System as is authorized by law. Each elected official is required to  
40 pay their share of the total Wisconsin Retirement System required contribution. Winnebago County will pay only its  
41 share of the total required Wisconsin Retirement System contribution. It is expressly recognized that these shares  
42 may change when the required Wisconsin Retirement System rate is adjusted, as authorized by law. These  
43 contributions shall be pre-taxed.

46 **BE IT FURTHER RESOLVED** by the Winnebago County Board of Supervisors that each elected official is  
47 conditionally eligible for, and may elect to receive, health insurance through Winnebago County’s group health  
48 insurance plan. This eligibility for health insurance coverage is expressly subject to the same terms and conditions  
49 (premium contribution, deductibles, co-pays, etc) as is applicable to full-time non-represented employees of  
50 Winnebago County. As part of said plan, Winnebago County retains the right to add or delete health insurance policy  
51 carriers and does not guarantee elected officials that it shall provide the same health insurance carrier or policy  
52 through the conclusion of the elected official’s term. Health insurance contribution amounts may be changed by  
53 external factors, insurance policy, or individual and family insurance premiums established by the insurer.
