
#### C. DECRIPTION AND JUSTIFICATION:

**Project Description:** This project is to replace the existing obsolete nurse call system at Park View Health Center with a new system. The existing system, Staff Call - Pro was purchased by GE Medical Systems and then removed from their product line. The availability of repair parts is limited to what is currently in the market place. Parts availability will be reduced as time goes on and the prices will begin to increase as parts get harder to find. This project will allow alternatives to be reviewed, a suitable product selected and installed before parts for the existing system are no longer available or become extremely costly.

Relationship to other projects and plans: This project is not related to any other project.


**Justification and alternatives considered:** There are two alternatives. The first is to do nothing and continue to use the existing system and buying replacement parts as long as they are available. This will lead to a situation where the parts are either no longer available or available at such an inflated price so as to make it not economically viable to continue operating the system. The second alternative is to systematically research available systems and manufacturers and determine the best method to replace the existing system and make an orderly transition.



Our son was injured in the parking lot at the Tri County Ice Arena in November. We have gone round and round with TCIA and their insurance company, Secura, regarding our claim for medical reimbursement. According to TCIA and Secura, the parking lot is the responsibility of Winnebago County. Below is the contact information for Secura.

Since the November incident, not only did our son have to go on antibiotics, he missed a day of school due to "concussion watch," and he had to remain off ice until his wound healed (almost 3 weeks). Upon his return he was so frightened he was going to get hurt again that he lost interest in hockey. We lost out of over half of his season, basically flushing over \$600 in hockey fees down the drain. Mentally he is afraid of hockey and the parking lot. We fought him multiple times to get dressed for hockey and it ended in tears each time.

We are seeking reimbursement for the medical bills and pain and suffering our son has gone through due to the mismanagement of the parking lot. Rep. Harris has attended a Board meeting and was aware of these issues. I hope that at this point someone will take this seriously and improve the conditions at TCIA.

We look forward to you helping put this behind us. We've retained a lawyer if needed, but are hoping to not have to go that route.

# Accident at Tri County Ice Arena

To Whom it May Concern:

On November 21st, my son tripped in the parking lot while leaving hockey practice and injured his forehead, requiring 9 stitches and antibiotics.

What appears to be a pathway between several grouped trees, are poorly cut stumps that led to his trip and fall. The lack of lighting made it difficult for him as well as myself to see that this "cut through" would be dangerous. Due to the lack of care in this parking lot and the lack of lighting, our son has received 9 stitches, bruises, was on a 3day concussion watch, missed a day of school, underwent a very stressful evening as he was covered in blood do the size of his wound, as well as, lost out on over a week of skating. We are very lucky he was not hurt worse than this.

I was not able to locate a first aid kit at the rink, nor saw anyone who could assist. Fortunately I have worked in the medical field and his father is a physician (who had to meet us at the rink to drive us to the clinic to care for his head so that I could maintain pressure). We sat at the rink for over 30 minutes to clot the blood with the napkins I grabbed at the concession stand, that luckily was open this night (as it is not consistently open).

Attached is copies of my letters that have been sent to the board and county back in the Spring stating that lack of maintained spaces and lack of care would lead to an injury. Unfortunately my prediction came true.

The continued lack of county support and lack of management has caused this issue.

We are lucky that our son is seemingly doing well, however, this should have never happened if the lights were on in the parking lot and the property was better maintained.

If an event happened like this at my office, we'd have a law suit on our hands as well as would be responsible for the medical bills.

I recommend the county and the board not let another year go by with out taking steps to better care for the lot and the rink to prevent further injuries.

#### Youth Hockey at Risk in the Fox Valley

The Fox Valley Youth Hockey Association (FVYHA) has been in negotiations with Winnebago County Officials over the past few years regarding the divestment (purchase) of the Tri-County Ice Arena, just recently on April 16, 2013. One of the FVYHA's mission is to secure sustainability of youth hockey in our area, as well as encourage and support children who are interested in this sport.

Tri-County Ice Arena was built in 1975 and has had very little renovations over the past 38 years despite budget hikes and increases in "ice time." The FVYHA, who provides over 43% of revenue as it is, has a comprehensive plan on how to rehabilitate this arena, balance the budget, and make cosmetic and safety improvements to move our players and visitors into the 21st century. http://foxvalley.pucksystems.com

From 1981-1991 the Tri-Counties (Winnebago/Calumet/Outagamie) supported an annual budget of over \$1million dollars, but not much improved. The FVYHA has offered to purchase this arena several times over the years and take the arena off of the county's/taxpayers hands. By supporting almost 50% of the TCIA, our hockey association continues to pay higher rates as the county turns a blind eye to the issues facing this facility. <u>FACT:</u> Comparing 2002 vs. 2011, there has been a 10% decrease in revenue, 30% increase in ice rates and 27% decrease in usage. It does not take an accountant to see that this is not an efficient way to spend our money.

As a parent of a young player and a mental health professional in the area, I know that participation in extracurricular opportunities is huge for our children. Providing a safe, clean, and easily accessible facility for our area youth to participate in hockey allows our community to benefit as well. Studies show that youth who are involved in extracurricular activities are less likely to engage in risky/delinquent behaviors, have higher levels of self-esteem, are less likely to become involved in drugs/alcohol/truancy, and are more likely to graduate from high school.

By allowing the FVYHA the ability to purchase the Tri-County Ice Arena, we will be able to increase participation at more reasonable rate so that children (no matter their socioeconomic level) have the opportunity to skate.

#### Dear Sirs,

My name is Meridith Starling and my son has been playing Hockey for the past 3 years, starting at age 4. The FVYHA has been an amazing part of boosting Mason's selfesteem, skills, and is an excellent outlet for his athletic ability and use of his high energy. Our son has ADHD and an Auditory Processing Disorder. In school he struggles to keep up with his peers academically, **but on the ice he is a leader**. Because of Hockey, he has a great outlet for his energy, has wonderful male role models/coaches, and he has gained so much self-esteem that he carries back into the class room.

Studies show, that youth who excel in sports (and have a safe, welcoming place to practice) have higher test scores, are less likely to run with the "wrong crowd," less likely to participate in risky behaviors (alcohol, drugs, etc), as well as graduate from high school and 4 year degree programs. Our plea to not VETO our purchase ability of TCIA is not just due to sports, but the long term effect it will have on our community.

**FACT:** Comparing 2002 vs. 2011, there has been a 10% decrease in revenue, 30% increase in ice rates and 27% decrease in usage. This is just not the way to continue. If we do not do something to "save" Tri-County I am afraid that many children will not be able to participate if the fees continue to rise and the facility continues to become more and more dilapidated.

Dear Sirs:

I moved to Neenah in July of 2010 with my husband, John and son Mason after relocating from Tennessee, Michigan, and Ohio. We have fallen in love with Neenah and our wonderful area. The best thing that "happened" to us was our discovery of Hockey through the FVYHA. Being from warmer states we had never even considered hockey for Mason.

Mason LOVES hockey and has been playing in the Fox Valley Youth Hockey Association (FVYHA) program, housed at Tri-County Ice Arena (TCIA) in Neenah since he was 4.

We, as FVHYA, have proposed to purchase and manage TCIA, and these matters were on the agenda during the County Board meeting April 16th. FVYHA is a community organization, and committed to preserving and growing hockey and skating programs in this area. I am asking for your consideration and support for FVYHA regarding the divestiture and management of the Arena.

Over the past several years, declining customer service by current rink management under the Tri-County Recreation Board (TCRB) and lack of consistent maintenance have impacted our communitybased hockey program. It has become an embarrassment when we host tournaments, is cold/dimly lit, and quite frankly not very encouraging to those who are new to not just Hockey, but skating.

 The Parking lot is a mess with pot holes that have yet to be repaired in our last 3 years of skating and has limited lighting which are both safety issues.

o The Locker Room conditions lack hygiene and the restrooms lack hot water

o There is little to no heat in the woman's or men's' bathrooms

• The glass is not clean and makes it hard to watch the games in the main rink; The glass in small rink has tape holding pieces together which is a safety hazard.

o The Carpet is outdated, worn, and most likely has never been properly cleaned.

We have very few heaters to make it comfortable for spectators or the players.

• The employees most likely are paid very little and are gruff. The nicest one is at the Concession Stand which brings on another subject; lack of nutritious food options.

• The fireplace may as well be for decoration, as it lacks heat and is inefficient.

Multiple efforts have been taken with current rink management in an attempt to address these issues, and few meaningful changes have resulted. For the past 3 years in our experience we sit on the fence each summer not knowing where our children will be skating due to rumors that it may close. FVYHA feels that arena ownership and management by a community association is the best way to ensure that the facility meets the needs of community user groups.

FVYHA is a **community association**, with players from across Winnebago County. TCIA is a **community facility**. We need a management group that is **community-focused**, with the passion and stewardship to maintain and preserve this community facility for our children and neighbors.

I believe FVYHA would do a better job at managing the rink because:

• Our organization operates with a strong sense of community pride and ownership – we will bring this sense of stewardship to managing the facility.

• We would use a more practical management approach that using both employees and volunteer efforts of 100+ committed families to properly run and manage TCIA.

• We are currently meeting the different hockey needs of players aged 4-14, across 5 levels with multiple teams in each with volunteers and strong family supports.

• With over 100+ families involved just in FVYHA we have a much stronger ability to use fundraising efforts to support arena operations and skating programming costs. Many own their own companies as well are able to write grants.

• By having control over TCIA we can better secure sponsors that would be able to endorse our program through these types of marketing:

 Arena naming rights, locker room sponsorships, rink boards, lobby renovation sponsorship, company names on jerseys, etc.

I urge you all to consider these thoughts when you are asked to vote on new ownership/management of the TCIA.

#### **Tri County Ice Arena**

#### LEASE AGREEMENT

- WHEREAS, Winnebago County (hereinafter referred to as "County") is a municipal corporation, organized and existing under the laws of the State of Wisconsin, which owns the two parcels of real estate described below in Exhibit 1, including the building and certain items of personalty existing thereon, and which is desirous of leasing said real estate, building and personality as an ice arena and exhibition/convention facility for the benefit of the general public;
- WHEREAS, Appleton Ice, Inc. (hereinafter referred to as "Lessee"), is desirous of leasing a facility and real estate for the purpose of operating an ice arena and exhibition/convention center in the Fox Valley:
- **NOW, THEREFORE, THIS AGREEMENT** is made, executed and delivered, in multiple original copies, between Winnebago County, as Lessor, and, Appleton Ice, Inc. as Lessee, on this 1st day of July, 2014, for good and valuable consideration, the receipt of which is hereby mutually acknowledged, according to the following terms and conditions:

**1. Leased Premises.** The County does hereby demise, let and lease unto Lessee the two parcels of real estate which are described more particularity in "Exhibit 1," attached hereto; as well as all buildings and structures existing thereon (referred to hereinafter collectively as "Leased Premises"), and those certain items of personal property listed in "Exhibit 2," which is attached hereto (referred to hereinafter as " County Personal Property").

**<u>2. Title to Property.</u>** The parties acknowledge and agree the items of personal property listed in "Exhibit 3" are not owned by County but by Tri County Recreation Association, despite the fact that said items presently are within the Leased Premises.

In the event either party desires to sell or give away an item of County Personal Property listed in Exhibit 2 of this Agreement (presently or as subsequently updated) which exceeds \$500 in value, such sale or gift shall be accomplished only by the mutual agreement of the parties. The party to take title to the item of property, if any, which replaces the sold or gifted item shall be as described in the succeeding paragraph.

In the event an item of County Personal Property becomes broken, dilapidated, or obsolete during the term of this lease, and such item of property is therefore replaced, title to the item of replacement property shall be determined by the following rules in the following sequence of priority:

a. If the replacement item is part of the refrigeration system for either the large or small ice rink, title shall be held by County.

b. If the replacement item is part of the rink boards or-plexi glass system for the large or small ice rink, title shall be held by County.

c. If the replacement item is an appliance, fixture, machine, furnishing, or other item of personal property that is portable or can be removed without significant physical damage to

the Leased Premises, then title shall be held by Lessee if paid for by Lessee; otherwise title shall be held by County.

d. If none of the preceding paragraphs apply and if the cost of the replacement item is less than \$500, then title shall be held by the party who pays for the replacement item.

In the event any items are lost or destroyed by theft, fire, flood, water damage or similar natural or accidental hazard, then the parties shall endeavor to reach an agreement as to who shall hold title to the property, keeping in mind the provisions of the preceding paragraphs in this section.

**<u>3. Purpose.</u>** The Leased Premises and Personal Property described in Exhibits 2 shall be predominantly used by Lessee as an ice arena and exhibition/convention center, and, shall be open for use by the public as such.

**<u>4. Term and Rental.</u>** This lease shall extend for a term of fifteen (15) years, commencing on July 1, 2014, and terminating on June 30, 2029. On July 1, 2014, and each July 1 thereafter during the term of this lease, Lessee shall pay to County the sum of One Dollar (\$1) as and for rent. At the end of the lease term, ownership of all county owned real and personal property listed in Exhibits 1 & 2 shall transfer to the lessee. In order for this to occur:

A. The facility shall be successfully and continuously operated as an Ice skating facility during the term of the lease.

B. The facility shall be properly maintained by Lessee during the term of this lease, including any capital improvements necessary to maintain the integrity of the building(s) and grounds (land, parking lots, etc.).

C. The facility shall be maintained by Lessee so as to meet all state, local and federal building safety and other codes required for a public building used for a skating or convention facility.

D. All other terms and conditions of the lease shall be met to the satisfaction of Winnebago County.

E. Failure to meet these terms and cure any violations thereof shall constitute grounds for termination of this Agreement.

**5.** Operation of Ice Arena and Exhibition/Convention Center Business. It shall be the duty of Lessee to operate, maintain, and manage an ice arena and exhibition/convention center business upon the Leased Premises. Lessee's responsibilities in operating, maintaining, and managing such business shall include, but are not limited to, the following: Contracting for services in the name of Lessee; employment of personnel by Lessee; purchase of materials, supplies and equipment by Lessee to insure the efficient and interrupted operation and management of the Leased Premises. All employees, agents and volunteers operating and maintaining such business shall be under the supervision and control of the Lessee.

**<u>6. Operation, Maintenance, Repair and capital Improvements of Leased Premises.</u> A fundamental responsibility of Lessee in running an Ice Arena and Exhibition/Convention** 

Center business shall be regular maintenance and repair of capital improvements of the Leased Premises.

All maintenance, repairs and capital improvements to the Leased Premises shall be the responsibility of the Lessee, performed in accordance with any and all applicable Federal and State Statutes and/or Town and County ordinances pertaining to work on a public building. The County Board and County Executive may approve performance of capital improvements to the premises provided that the required majority of the Board approves appropriation of funds for such improvements.

Lessee shall be specifically responsible for prompt, diligent maintenance, repair or replacement of the following structures or systems: (1) the exterior of the building on the Leased Premises, including the roof, (2) the refrigeration system for the large and small ice rinks, (3) the utility systems servicing the building on the Leased Premises, (4) the skating boards and Plexiglas and the skating surface and (5) the parking lot on the Leased Premises.

Lessee does promise and agree to exercise due diligence to keep the Leased Premises clean and in good condition, as well as to pay the cost of routine and ordinary cleaning and maintenance.

County agrees that it will be responsible for winter plowing of the parking lot of leased premises during the period of the lease term. Lessee agrees that County shall not be held responsible for any damage to the lot while snow plowing. Lessee is responsible for any repairs. Should the ownership of the facility be transferred to lessee it will become the responsibility of lessee to plow any lots.

The board of directors of Lessee shall review the total capital improvement program of Lessee and make a report to the County Board at its July regular business meeting annually outlining all proposed capital improvements with regard to multi-use or year round recreational use.

**<u>7. Acceptance of Leased Premises.</u>** Lessee accepts the Leased Premises and Personal Property in the condition as it exists at the time of execution of this agreement.

County agrees that any ice rental fees that have been prepaid or already collected for the 2014-2015 season to commence in September, 2014 are due and owing to Lessee and will assist Lessee in collecting those amounts.

**<u>8. Improvements: Fixtures.</u>** Lessee may install removable partitions, counters and the like incidental to the use of the Leased premises. Lessee shall not make any substantial structural changes, additions or improvements without express written consent of the County board.

Lessee may remove its own fixtures, equipment, removable partitions and counters from the Leased Premises at the expiration of this agreement and, in the event of damage by reason of such removal, Lessee shall reimburse County for any such damage.

<u>9. Insurance.</u> Lessee agrees that, in order to protect itself, County and its officers, boards, employees and representatives under the indemnity provisions of paragraph 10

below, it will at all times during the term of this agreement keep in force, at a minimum, the insurance coverage's outlined in Exhibit 4 which is attached hereto

Auto liability coverage is not necessary unless Lessee owns a vehicle, It is necessary; however that Lessee obtains non-owned and hired auto liability coverage.

County will obtain, at its expense, policies for the building and county owned contents, as well as boiler and machinery coverages.

Policies shall be issued by a company or companies authorized to do business in the State of Wisconsin and licensed by the Wisconsin insurance Department. Coverage afforded shall apply as primary, with the County, their boards, officers, employees and representatives as additional named insured's. County shall be given thirty (30) days advance notice of cancellation or nonrenewal during the term of this agreement. Upon execution of this agreement, Lessee shall furnish County with a certificate of insurance, and upon request, certified copies of the required insurance policies. In the event any action, suit, or other proceeding is brought against County upon any matter herein indemnified against, County shall, within five (5) working days, give notice thereof to Lessee and shall cooperate with their attorneys in the defense of the action, suit or other proceeding.

<u>10. Indemnification.</u> Lessee agrees at all times during the term of this agreement to indemnify, save harmless and defend County, their board, officers, employees and representatives against any and all liability, loses, damages, costs or expenses which County, their board, officers, employees and representatives may sustain, incur or be required to pay by reason of Lessee occupying, furnishing services or goods required to be provided under this agreement, provided, however, that Lessee shall not indemnify County for liabilities, losses, charges, costs, expenses or fees caused solely by or resulting from the acts or omissions of County, their agencies, board, officers, employees or representatives.

Lessee and County agree that they shall not be liable to each other for any loss or damage to property or injury to or death to persons occurring as a result of Lessee occupying or furnishing services or goods required to be provided under this agreement. This release shall apply to the extent such loss or damage to property or injury to or death of persons is covered by insurance, regardless of weather such insurance is payable to or protects Lessee or County, or both of them. Nothing in this paragraph shall be construed to impose any other liability upon Lessee or County than would have existed in the absence of this paragraph

<u>11. Taxes and Special Assessments.</u> Should the Lessee lose its tax exempt status and become a taxable entity anytime in the future, then lessee shall be responsible for payment of any real estate taxes. Lessee shall bear, pay and discharge, when due, all special assessments, sewer charges, water charges, utility meter charges and all other charges levied, assessed or imposed during the term of this agreement by any governmental or quasi-governmental body or authority. The parties acknowledge that street special assessments against the property (roughly \$35,000) for road improvements shall be assessed presently or in the near future. Lessee understands and agrees that it will be responsible for payment of these special assessments

**<u>12. Budgets, Financial Arrangements an Accounting Practices</u>. Financial statements and bookkeeping documents will be provided or made available to the county executive of Winnebago County by Lessee upon reasonable request.** 

**<u>13. Assignment and Subleasing.</u>** Lessee shall not assign this agreement. Lessee shall not sublease the Leased Premises or Personal Property or any part thereof for purposes other than those outlines in Paragraph 3 of this agreement without the express permission of County. County agrees that permission for such sublease shall not be unreasonably withheld.

**<u>14. Name of Facility</u>**: Lessee is hereby given the authority to sell the name or change the name of the facility without the approval of County.

**15. Default.** It is mutually agreed that in the event Lessee shall default in any of the terms or conditions of this agreement, County may forward written notice of such default by certified mail addressed to Lessee and Lessee agrees that if it has defaulted as set forth in said notice, it will correct such default within twenty (20) days after the date of mailing of said notice, or in the event such default is of a character to require more than twenty (20) days to correct, then, Lessee will use diligence to correct such default. In the event Lessee shall fail to cure such default as herein set forth, County may terminate this agreement.

<u>16. Termination of Agreement.</u> Except as hereinafter provided, this agreement may be terminated by only the mutual written agreement of County and Lessee.

<u>17. Adding Arena User Groups.</u> It is anticipated by Lessee that it will be discussing expanded use of the Leased Premises with local sport and recreation clubs. If such discussion requires the input of County, County does hereby agree to participate in such negotiations.

18. Applicable Law and Severability. This agreement and any interpretation thereof shall be governed by the laws of the State of Wisconsin The parties agree that venue for any action commenced in state court shall be the Circuit Court of Winnebago County. If it should be determined by a court of competent jurisdiction that any of the terms hereof are in conflict with any rule of law or statutory provision of the State of Wisconsin, then the terms of the contract which so conflict with the law of Wisconsin shall be deemed inoperative, null and void, and shall be deemed modified to conform to such rule of law, all without invalidating any of the remaining provisions of this contract or the enforceability thereof.

<u>**19.**</u> Parties Bound.</u> It is mutually agreed that all of the covenants, terms and conditions of this lease shall extend, apply to and firmly bind the successors and assigns of the respective parties hereto as fully as the respective parties themselves are bound".

**20. Notifications to Parties.** All official notices related to this agreement directed to the County shall be mailed to the county at the following address: Winnebago County Finance Director, PO Box 2808, Oshkosh, WI 54903-2808

All official notices related to this agreement directed to the lessee shall be mailed to the following address: Appleton Ice, Inc. Attn: Troy Schwehr, 1717 E. Witzke Blvd, Appleton, WI 54911.

- 2. Hired Automobiles
- 3. Non-Owned Automobiles
- 4. Auto liability coverage is not necessary unless lessee owns a vehicle. It is necessary, however that Lessee obtains non-owned and hired auto liability coverage.
- II. The certificate shall list the **Certificate Holder and Address as follows:** Winnebago County, Attn: Insurance Administrator, Winnebago County Courthouse, P.O. Box 2808, Oshkosh, WI 54903-2808. The Winnebago County Department(s) involved shall be listed under "Description of Operations".
- III. Such insurance shall include under the **General Liability and Automobile Liability policies** Winnebago County, its employees, elected officials, representatives, and members of its boards and/or commissions as "Additional Insureds".
- IV. Contractor shall require **subcontractor**; if applicable, to furnish identical certificates of insurance to the Winnebago County Insurance Administrator prior to contract taking effect.



### C. DECRIPTION AND JUSTIFICATION:

**Project Description:** This project provides for design and construction of an improved intersection at CTH CB and CTH BB. The project includes traffic improvements, turn lanes, some limited curb & gutter and storm sewer along with new signals. This is a joint project with Outagamie County.

Relationship to other projects and plans: None in Winnebago County

**Justification and alternatives considered:** Outagamie County has a project to improve CTH CB north of BB. Part of that project includes the intersection with CB improvement. The existing intersection operates at a "C" level in terms of traffic backup and flow. An upgrade to the intersection layout with improved signalization and lane designations along with an improved pavement will greatly enhance the operations and traffic flows.



# Winnebago County Board Meeting May 20, 2014 Project Presentation – Reconstruction of the CTH CB & BB Intersection

The County Highway Department has planned for and is hopeful of reconstructing the CTH CB & BB Intersection during this coming construction season. CTH BB is a border highway with Outagamie County and the CB intersection with BB is where the jurisdictions meet in terms of maintenance responsibilities.

This project has been planned by and will be constructed jointly with Outagamie County. What follows is a brief outline intended to give the County Board a summary of the proposed CB & BB Intersection Reconstruction Project in the Town of Menasha.

This project has been identified in our County Highway Capital Improvement Plan for reconstruction in 2014. Several years ago, discussions began with Outagamie County to consider an improvement to this intersection. This is a part of a larger project for Outagamie County. They plan on constructing an improvement from the CB & BB intersection north on CTH CB toward the airport. The design of this larger project was undertaken a couple of years ago with plans and specifications being completed for the intersection in late 2013 and right of way being purchased this past winter.

This project will reconstruct the intersection at CTH BB & CB and will remove and replace asphalt pavement and greatly improve the traffic function of the intersection. The traffic volumes in this intersection are significant with BB seeing counts in 5,000 range daily and CB being approximately the same if not higher. The intersection presently functions at a Level of Service C during high volume times of the day. The project should improve that function to a service level of A.

The project will totally reconstruct and widen the existing intersection and add additional lanes for straight through and turning movements. There will be some curb and gutter in the intersection and some limited storm sewer and drainage improvements done as a part of the project. The traffic signals currently in use at that location are gradually becoming somewhat of a maintenance problem and the technology is rather out of date. Finding replacement parts can be very difficult with older signal systems such as this

The signals, curb and gutter and storm sewer work will be let to bid with Outagamie County doing most of the remaining work. We have a lot of work in other areas of the County and it makes sense to work cooperatively with Outagamie on this, since they'll have crews and machines on the project anyway.


Winnebago County has jurisdiction of CTH BB in this area and is responsible for the traffic signal cost, plus a share of the roadway improvement costs. Outagamie County is the lead agency on the project and will be responsible for their share of the roadway improvements and is doing the major portion of the engineering.

The condition of BB under our maintenance jurisdiction and the entire BB corridor in our County is showing signs of age and deteriorating condition. This is a primary travel corridor in the area and the traffic volumes continue to increase. Improvements and possibly expansion of BB in order to accommodate increases in volume will need to be considered in the near future.

The Winnebago County cost estimate for our share including the signal work is approximately \$210,000. The Personnel and Finance Committee discussed this project at the meeting held on May 1st and approved it going on to the County Board for presentation. I'll be bringing a resolution for the funding back to the Board in at the June meeting.

I appreciate the Board allowing me to speak on this project.

## PUBLIC PARTICIPATION PLAN FOR THE 10-YEAR UPDATE OF THE MULTI-JURISDICTIONAL COMPREHENSIVE PLAN FOR WINNEBAGO COUNTY, WISCONSIN

## INTRODUCTION

The Winnebago County Board of Supervisors adopted a countywide comprehensive plan on March 21, 2006, and now desires to work towards completing a 10-year update of that plan. To help ensure the updated plan reflects the needs of county residents and property owners, citizen input will be encouraged throughout the preparation, review, and adoption of the plan. This public participation plan forms the basic framework for achieving an interactive dialogue between local decision makers, county officials, and the citizens of Winnebago County.

## **OBJECTIVES FOR PUBLIC INVOLVEMENT**

Public participation is intended to achieve the following objectives:

- The process engages people of all races, ethnic backgrounds, and income levels.
- The public has opportunities to provide input (both formally and informally) to the County.
- The public has access to technical information and analyses performed during the process.
- Members of the County Board of Supervisors have input from a broad range of perspectives and interests in the community.
- Public input is elicited through a variety of means (electronic, printed, and oral) in such a way that it may be carefully considered and responded to in a timely fashion.
- The process strengthens the sense of community and civic engagement.
- The process furthers the vision of having active and positive participation throughout the process by those most directly affected by County decision making.

## **RESPONSIBILITY FOR IMPLEMENTATION**

Each of the following will share the responsibility for implementing the public participation activities described in this plan:

- Winnebago County Board of Supervisors
- Winnebago County Planning and Zoning Committee
- Winnebago County Planning and Zoning Department

However, the County Board of Supervisors will ultimately determine the direction and content of the comprehensive plan update.

### PLANNED PUBLIC PARTICIPATION ACTIVITIES

- Establish an advisory steering committee to promote feedback and oversee the plan development
- Utilize a website to post information related to the project
- Committee meeting updates
- Conduct one or more public hearings
- Meet with the Town Boards in the county



- Conduct regional meetings with town officials to share information and obtain feedback
- Conduct a community open house
- County Board meetings
- Provide opportunities for the public to submit oral and written comments
- Post various drafts of the plan on the project website along with other supporting information as appropriate
- Provide copies of all public documents upon request

## PUBLIC PARTICIPATION GUIDELINES

A public hearing will be conducted as part of the plan amendment process to allow for formal public testimony. All other public meetings should follow the following format:

- An agenda will be established that clearly defines the purpose of the meeting, the items to be discussed, and any actions that may be taken.
- The scheduled date, time, and place will be convenient to encourage participation by county residents.
- A clearly identifiable facilitator or chair will conduct the meeting in an orderly fashion to ensure that all attendees have an opportunity to offer comments, discuss issues, or provide testimony.
- The facilitator or chair will provide opening remarks outlining the purpose of the meeting, procedures attendees should use during the meeting when offering input, and how the input will be used.
- As appropriate, an overview of documents or proposals to be considered will be discussed.
- All persons attending the meeting that desire to participate should be allowed to do so. However, specific factors, such as the meeting or hearing purpose, number in attendance, time considerations, or future opportunities to participate, may require that appropriate constraints be applied. These constraints will be clearly outlined by the facilitator.
- Special arrangements will be made under the provisions of the Americans with Disabilities Act (ADA) with sufficient advance notice.

## **OPPORTUNITY FOR WRITTEN COMMENTS**

- The project website will include the name, address, and email address (if applicable) of a person(s) to whom written comments should be sent, along with any deadlines for submitting comments.
- At public meetings or hearings, the facilitator or chair will clearly announce any deadline for submitting written comments, if such comments are allowed subsequent to the meeting or hearing.
- Persons speaking or testifying will be encouraged to concisely express their comments and if appropriate provide specific details in writing.

## CONSIDERATION OF PUBLIC COMMENTS

• Decision makers may continue a public hearing for the purpose of addressing public comments, provided the time and date of the public hearing is announced at the time the public hearing is tabled.



• Substantive written comments relating to studies, analyses, or reports, along with appropriate responses, will be included in published documents if deemed appropriate.

## PUBLIC NOTICES FOR MEETINGS AND HEARINGS

Public notices of all meetings and public hearings will be prepared and distributed consistent with applicable notice requirements of the Wisconsin Open Meetings Law, and any other notice requirements imposed by local ordinance or bylaws. At a minimum, the requirements of §19.31, Wisconsin Statutes, pertaining to public meetings and notification will be met. Public notices for public hearings will be placed in the County's official paper and may be posted on the project website.

The following information should be included in any notice:

- Name of the governmental body that will meet.
- Date, time and location of the hearing.
- General description of the matter to be discussed and acted upon.
- Notice that interested persons may present testimony regarding matters on the agenda at the meeting/hearing or in writing to the board or committee prior to a specified deadline.
- Contact information for further information about the proposal.

## C. DECRIPTION AND JUSTIFICATION:

**Project Description:** This project is to maintain and repair the masonry surfaces of various County Facilities. Each building will be surveyed on a regular basis to identify potential masonry problems before they actually occur. Remedial action will be taken to prevent a building envelop failure and more costly repairs or replacement. The goal of this program is to maximize the life of the masonry surfaces covering the facilities.

**Relationship to other projects and plans:** This project works in conjunction with the Comprehensive Needs Study and all the other projects for each facility. If a facility is scheduled for major renovation, masonry repairs will become a part of the project to minimize disruption to the facility occupants and consolidate work done to a facility. If a facility is scheduled for disposal, only the basic maintenance of the masonry will be accomplished, avoiding unnecessary costs.

**Justification and alternatives considered:** There are two alternatives to this program. The first is to do minimal planning. This will continue the current practice of having masonry joints fail without warning and causing other collateral damage due to water or weather intrusion. Emergency repairs are costly and are usually performed under less than ideal conditions. There usually is no funding for emergency repairs. The repairs are very disruptive to the facility occupants. The collateral damage due to water leakage or weather intrusion can be very costly due to electronic equipment that may be damaged, employee or visitor injuries.

The second alternative is to have a proactive masonry maintenance program. This program will identify potential masonry problems before they occur. Repairs can be planned and funded through the budget or capital improvements planning process. Occupants are aware of pending repairs and plans can be established to minimize disruption to the daily activities. Projects can be competitively bid early in the season to get the best price.

# 4 TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:

5 WHEREAS, the Continental Congress, by a Declaration of Independence, dated July 4, 1776, clearly 6 declared the inhabitants of New Hampshire, Massachusetts, Rhode Island, Connecticut, New York, New Jersey, 7 Pennsylvania, Delaware, Maryland, Virginia, North Carolina, South Carolina and Georgia, were no longer colonial 8 subjects to be exploited arbitrarily by servants of the King and Parliament of Great Britain, but now were free citizens 9 of their own territories, and that free citizens should constitute the governments for those territories; and

WHEREAS, the Continental Congress provided that same day, by orders of their House, that their Declaration should be proclaimed aloud and published to the free citizens of the territories represented in their Congress; and

WHEREAS, the notification of the Declaration to responsible citizens was then done by sheriffs who proclaimed it at the courthouse steps, by clergymen who read it from their pulpits, and by printers who printed it in their gazettes; and

WHEREAS, the Continental Congress thus initiated a process that has created the Constitutions and state
 governments of our Union including the Constitution and government of the State of Wisconsin.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby requests Sheriff John Matz to read the Declaration of Independence from the steps of the Courthouse at 8:00 a.m. on the morning of July 4, 2014, as this was the custom in the early history of our country.



# C. DECRIPTION AND JUSTIFICATION:

**Project Description:** This project is to increase the number of parking stalls at the Jail Complex. During the original design and construction of the Jail complex, an additional parking lot was identified but not constructed. This project would construct the parking lot. Current conditions and staffing levels at the Jail have filled the parking lot. This is compounded when shift change occurs. The number of vehicles needing to park almost doubles. In order for staff to report on time, vehicles are parked wherever there is space whether or not it is a parking stall.

Relationship to other projects and plans: No relationship to other projects

Justification and alternatives considered: There are only two options available. Do nothing and to increase the parking. If nothing is done, the current parking practices will continue. This can lead to damage to grassy areas used as a parking spot. Cars could be parked in the way of departing staff or blocking vehicular circulation routes. Staff could be delayed reporting for duty as they try to find a safe place to park their vehicle. If the parking is expanded, staff will not be delayed in reporting for duty, grassy areas and landscaped areas will not be damaged. Vehicular circulation will not be impeded.



Additionally the caulk has been exposed to 10 years of ultraviolet radiation from the sun and seasonal weather changes. These conditions have aged the caulk and it is now at the end of its useful life. This project is to remove the existing caulk and to replace it with new.
