The information you supply will be used by the Mediation Program to make an initial determination of whether your case is suitable for mediation. A non-refundable \$100.00 fee is charged to both the homeowner and the lender **once the case has been accepted for mediation.**

Requesting Mediation does not halt the foreclosure process. **You are still required to comply with all mandatory deadlines, including the time to answer the Complaint.**
