RE: RESOLUTION 314-032024: Approving \$387,500 from the Spirit Fund's Government Identified Community Projects Category to Fund the South Leg of a 2-Lane Roundabout at the Intersection of Leonard Point Road and State Highway 21 in The Town of Algoma

## **General Description:**

The Wisconsin Department of Transportation allocated funding to construct a 2-lane roundabout at Leonard Point Road and STH 21. The Town of Algoma has agreed to fund the south leg of the roundabout to facilitate mixed-use development on some 250 acres. The fourth leg of the roundabout is the first section to be built and will extend south and one day connect with Clairville Road. The roundabout and road extension has been discussed for about 30 years and would facilitate much needed mixed use development that would significantly increase the tax base, provide jobs, all types of residential options, and additional recreational opportunities. The roundabout works in conjunction with the reconstruction of Omro Road in 2021 and the planned reconstruction of Leonard Point Road in 2026.

## **Background:**

For many years, the Wisconsin Department of Transportation denied access to the properties located south of the Leonard Point Road and STH 21 because of the design of STH 21. As a result, it has remained undeveloped. The roundabout at that location is experiencing an increasing number of vehicle crashes due to an steady increase in traffic using STH 21. State officials finally allocated funding to construct a 2-lane roundabout at Leonard Point Road and STH 21. The Town of Algoma has agreed to fund the south leg of the roundabout to facilitate mixed-use development on some 250 acres that has been planned for for decades. The owner of the property is also the

developer of the property. They are ready to move forward with a comprehensive plan for mixed use development that would significantly increase the tax base, provide jobs, all types of residential options, and additional recreational opportunities. The fourth leg of the roundabout would also serve as the first section of the road that will extend south and one day connect with Clairville Road.

**Policy Discussion:**

Absent Spirit Funds being allocated, the Town will need to bond for this amount in addition to the \$1.4 million the Town is required to contribute toward the reconstruction of Leonard Point Road in 2026. Town taxpayers will have to pay back all of this debt over 20-25 years. The maintenance responsibility of the Winnebago County Highway Department for the state highway lanes, and Town of Algoma for the roundabout and the south and north bound legs of the roundabout.

**RESOLUTION: Approving \$387,500 from the Spirit Fund's Government Identified Community Projects Category to Fund the South Leg of a 2-Lane Roundabout at the Intersection of Leonard Point Road and State Highway 21 in The Town of Algoma**

**TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**

**WHEREAS**, a 2-lane roundabout is to be constructed in 2027 and the Town of Algoma is responsible for funding the south leg of the roundabout; and

**WHEREAS**, the Wisconsin Department of Transportation is funding the north, east, and west-bound legs of the roundabout; and

**WHEREAS**, the total cost of the roundabout is \$6,300,000, and

**WHEREAS**, the Town of Algoma completed a Spirit Fund application on-time, requesting \$387,500 , and

**WHEREAS**, the ARPA Strategy and Outcomes Commission recommends a grant of \$387,500 from the Winnebago County Spirit Fund; and

**NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of Supervisors that \$387,500 from the Spirit Fund's Government Identified Community Project category be approved to fund the south leg of a 2-lane roundabout at the intersection of Leonard Point Road and State Highway 21 in the Town of Algoma.

**BE IT FURTHER RESOLVED** by the Winnebago County Board of Supervisors that upon completion of the project, the Town of Algoma will submit supporting documentation to the Winnebago County Finance Director outlining the expenditures. The documentation will be submitted within 6 months of the completion of the project but not to exceed 5 years from date of disbursement.

**BE IT FURTHER RESOLVED** by the Winnebago County Board of Supervisors that the Town of Algoma shall be responsible for reimbursement to Winnebago County for any disbursed funds which are determined by Winnebago County to have been misused or misappropriated. Any reimbursement of funds which is required by Winnebago County shall be due within 45 days after giving written notice to recipient of such misuse or misappropriation.

*Fiscal Note: This resolution will not amend the County Budget. \$387,500 will be authorized for use from the Spirit Fund.*
