### **AIRPORT ZONING UPDATE MEETING**

The City of Oshkosh and Winnebago County will be hosting a public informational meeting to provide the public an opportunity to provide feedback on a proposed update to Wittman Regional Airport Zoning Code. The meeting will be held on Wednesday, October 12, 2022 at 6:00 P.M. at City Hall in Room 404.

In 2019, the City of Oshkosh, in conjunction with the consulting firm Mead & Hunt, began reviewing the existing Wittman Regional Airport Zoning Ordinance. In particular, the City was interested in updating the Zoning Ordinance to provide additional flexibility in regards to the types of compatible land uses that are permitted in proximity to Wittman Regional Airport. The overall goal of the project is to maintain compatible land uses around the airport while allowing the City & County to more fully implement their land use plans in the airport and surrounding commercial areas. The City of Oshkosh & Winnebago County will be presenting an overview of the proposed update at the meeting and will gather feedback from participants. Meeting notices were mailed to property owners who are located in areas that may be affected by the proposed update.
