Using **Google Chrome** browser, click the link provided and download the Zoom program or click view in browser. Chrome is the only browser that works. Once in the meeting enable your microphone via internet/device by selecting the microphone icon or follow the call in by telephone instructions. Please see attached screenshot on how to activate microphone.

From Telephone

Dial (312) 626-6799 and enter the meeting ID above when prompted. If you are already participating in the meeting by computer and using the call in feature for a microphone, enter your participant ID. If you are participating only by telephone, do not enter an ID.

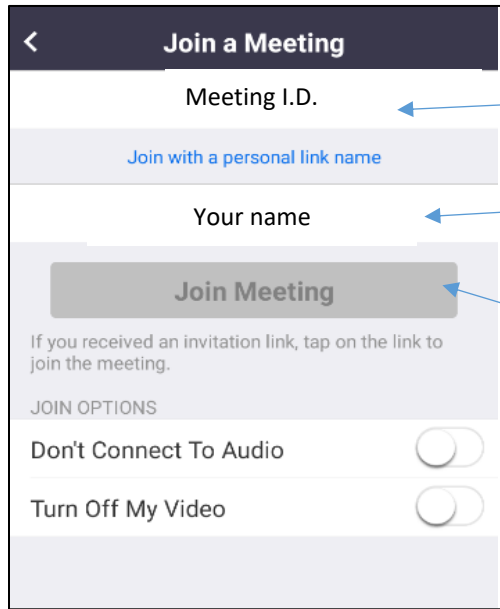
Meeting procedures:

If you have a question or you wish to speak for or against an agenda item, please use the raise hand feature of the application, or message the Winnebago County Planning and Zoning Department within the application. For individuals who wish to speak, their microphones and/or cameras will be activated one at a time when the committee opens the floor for comments.

Please note in an effort to reduce any technological issues, any testimony that was given at a previous hearing on the agenda item is still on the record and will be considered by the committee.

Please do not use the chat feature for anything other than to communicate to the host (Winnebago County Planning and Zoning Department) that you would like to speak.

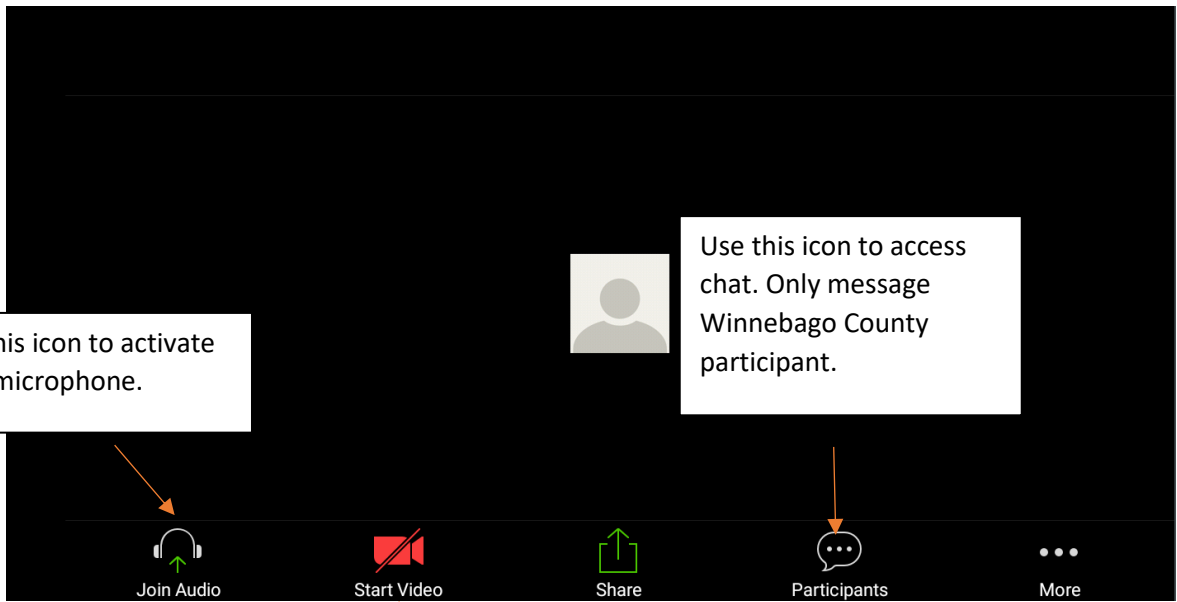
