- 9. <u>Director's Report on Department Operations</u>: J. Rabe presented the Director's Report on Department Operations to the Solid Waste Management Board (SWMB) as follows:
 - September 30, 2022 Executive email highlighted the Solid Waste staff efforts during July 2022 Transfer Station fire and included Tri-County Recycling Facility virtual tour link
 - Transfer Station operations continue shipping waste to the Outagamie County (OC) and Brown County landfills, and shipping recycling to the Tri-County Recycling Facility at OC
 - Trane chiller continues to have issues compressor 2A repairs necessary; parts ordered and hope to have repairs completed by late-October
 - Engine #2R suffered an issue with Cylinder 10 on September 12, 2022; repair parts ordered and engine will be down until mid to late-October.
 - During decoking on Engine #3, connecting rod issues were noted and further repairs are necessary; evaluating parts/repair options but engine will be down for an extended period of time
 - Landfill Gas to Energy operations continue running Engine #4 only when the chiller is able to operate (cooler temps); periodic flare operation continues when necessary
 - Recruitment: Temporary Project Equipment Operator Derek Roesler started on September 22, 2022 to assist with operations during long-term workman's comp employee absence (currently a 6-month term)
 - Tri-County Recycling article in the October 5, 2022 Post Crescent

Discussion ensued amongst the SWMB.
