**Kate Pfaendtner** called the meeting to order at 3:00 PM.

1. **Public Comments:** No public comments.
2. **Approve Minutes of the May 8, 2023 Meeting:** **Rob Paterson** pointed out corrections to the May minutes including on page two under Brook Slick changing the word "bout" to "about" and changing "ae" to "are" under Jim Lauer. May meeting minutes were approved as amended.
3. **Transportation update – Nicole Davis-Dawald and Beth Roberts:** **Beth Roberts** reported that due to inefficiencies, Route 10 is being replaced by a new program being piloted by the City of Oshkosh called GO Connect. GO Connect will transport riders between the Oshkosh Downtown Transit Center and the Neenah Transit Center at a cost of \$5 for each one-way trip. There is no need to qualify for the service as it is available to the general to the public. Riders needs to call at least 24 hours in advance to schedule a transport. To date, **Nicole Davis-Dawald** has not received any calls regarding the new program. A survey is being conducted to gather ideas and feedback for the new transit plan for the county which begins in 2024.
4. **Partnership Family Care Option – Brian Nagler:** **Brian Nagler** reported as of January 1<sup>st</sup> there is a new Family Care Partnership option available to Winnebago County residents. Members enrolled in the Partnership Program work with a care team consisting of medical staff and a case manager who assist with acute care and transition planning. The Partnership option is available in 12 counties in the Wisconsin: Brown, Columbia, Dane, Dodge, Fond du Lac, Jefferson, Manitowoc, Ozaukee, Sauk, Washington, Waukesha, and Winnebago Counties. The State sent out letters to inform qualifying individuals of this new option.
5. **Wheelchair Wash – Beth Roberts:** **Beth Roberts** reported that 12 chairs were scrubbed down and inspected at the wheelchair wash this year. A lot of advertising was done prior to the event including supportive homecare agencies, signage, newspaper ads, television, news, radio, Facebook, and in the ADRC newsletter. The event included free lunch, music, face painting, and door prizes.

6. **New Committee Member Updates – Beth Roberts:** **Beth Roberts** reported that the one existing committee member opening has now been filled. Beth contacted the member who has not been in attendance to inquire about the reason for lack of attendance. Terms are three years and there can be two consecutive three-year term limitation for members.
