#### 4. Update/discussion: Status of where Municipalities stand regarding the \$145,000 Spirit Funds distribution.

Paul Kaiser provided a brief update and handout for the commission on where all the towns and municipalities are at in this process. Mr. Kaiser had received and reviewed information from five more municipalities. He sent out funds to the Town of Algoma, Town of Nepeuskun, and the Village of Fox Crossing. They should have received those funds today. Mr. Kaiser is waiting on some additional information from the Town of Black Wolf and Town of Wolf River at this time.

# 5. Discussion/Possible Action: Winnebago County Fire Chiefs Association (WCFCA) – Replace mobile, portable and DVRS radios in the county in the amount of \$3.2M

Motion by Supervisor Cox, seconded by Supervisor Belter to bring item to the floor for discussion.

Motion by Supervisor Farrey, seconded by Supervisor Buck, to create a resolution to appropriate \$2.1 Million to address the request for the Fire Chief's Association to replace mobile, portable and DVRS radios within Winnebago County.

#### 6. Discussion/Possible Action: Continue prioritizing and selection of projects for Spirit Funding.

The commission continued discussing each project separately and selected projects that would meet criteria for Spirit Funding. As the commission discussed each project, they identified details of the project; cost of the project; requested amounts; and determined the minimum and maximum amounts to be considered by the commission. The commission will continue this process at the next meeting.

Motion by Supervisor Doemel, seconded by Supervisor Farrey, to draft four (4) additional resolutions to review, and vote on at the next meeting. These resolutions will have a blank funding amount. The commission will discuss and determine the amount for those projects at the next meeting. Those four (4) resolutions will be:

- Assist in the Purchase of the Beach Building for Christine Ann Domestic Abuse Services, Inc.
- Assist in the Purchase and Renovation of New Facilities for the Damascus Road Project
- Expand Solutions Recovery Housing
- Renovate and Expand St. Vincent de Paul Neenah Menasha
