

**WINNEBAGO COUNTY BOARD MEETING  
TUESDAY, MARCH 16, 2010**

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

## **REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS**

Supervisor Eisen reported on his attendance at a library trustee training session sponsored by the WinneFox Library System on March 15.

Supervisor Norton reported that the Parks & Recreation Committee's community park beach ad hoc committee has completed their study of the beach and will give their report to the committee in April. Supervisor Norton thanked the other members of the ad hoc committee for their work on this project.

Supervisor Norton reported that Governor Doyle signed Act 164 into law, which provides more state funding for people to receive public defender services.

Supervisor Sievert commended Sue Ashton, a nurse in the Winnebago County Public Health Department, for a magazine article she wrote about the importance of properly disposing of unused medicines.

Supervisor Lennon read a press release announcing Governor Doyle's approval of funding for three projects at Wittman Regional Airport.

Supervisor Rengstorf reported that the Judiciary & Public Safety Committee will be discussing County Board rules at their March 29 meeting. If anyone has any suggestions for changes to the rules, they should contact Supervisor Rengstorf.

Supervisor Kline reported that the Legislative Committee will be meeting on Monday, March 22 @ 8:30 a.m. at the James P. Coughlin Center.

Supervisor Barker reported on how important it is that people fill out their U.S. Census forms and send them back. If people send their forms back by the deadline, it will save the federal government approximately \$1.5 Billion in follow-up visits by census workers.

Supervisor Brennand reported that the Petition for Zoning Amendment from Una B. Fredrick in the Town of Neenah that was read into the record by the clerk has been withdrawn.

Supervisor Griesbach reported that the Officer Jason Weber of the Town of Menasha Police Department helped to establish a drop-off site for unused medication in the Town of Menasha.

## **COUNTY EXECUTIVE'S REPORT**

Executive Harris pointed out that a timeline for the Park View Health Center buildings and the Oshkosh B'Gosh property was distributed to the Board for their information.

Executive Harris reported that at the end of 2009, the balance in undesignated reserves was approximately \$11.7 Million. He explained that the \$1 Million in surplus funds from various county departments in 2009 that normally would have gone into undesignated reserves was needed to increase property taxes receivables. Executive Harris explained that the county is required to compensate municipalities for any property taxes that property owners don't pay the municipality by the tax deadline. The county then collects those taxes from the individual property owners. Because of the current economy, there were more unpaid taxes that the county needed to reimburse the municipalities for, so property taxes receivables needed to be increased by approximately \$1 Million.

Executive Harris shared information from the General Accounting Office's March 2009 GAO Report to the U.S. Congress on state and local governments. He explained that they are anticipating short and long-term "fiscal challenges" through 2060.

Executive Harris emphasized the importance of people filling out the U.S. Census form and getting it sent back by the deadline.

Chairman Albrecht explained that this is the last meeting of this County Board of Supervisors and thanked those who won't be back for another term for their service on this Board. Chairman Albrecht wished all those who are running for re-election good luck.

**RESOLUTION NO. 383-32010:      Appropriate \$322,000 to the North Parking Lot Resurfacing Project at the UW Fox Valley Campus and Fund County Share with a Bond Issue of \$161,000**

WHEREAS, the North parking lot at the UW Fox Valley Campus has had significant deterioration and is in need of resurfacing before the damage requires a complete reconstruction; and

WHEREAS, Winnebago and Outagamie Counties are jointly responsible for the buildings and grounds; and

WHEREAS, large pot holes and cracks increase the risk of liability if someone were to become injured as a result of the poor condition; and

WHEREAS, your UW Fox Valley Board of Trustees recommends that this project be undertaken; and

WHEREAS, this project is included in the County 5-Year Capital Improvements Plan and is scheduled for 2010.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$322,000 to a project to resurface the North parking lot at UW Fox Valley contingent on Outagamie County agreeing to fund ½ of the cost.

BE IT FURTHER RESOLVED that funds to pay for said improvements be transferred from the General Fund of Winnebago County to the North Parking Lot Resurfacing Project at UW Fox Valley Capital Project fund with the General Fund being reimbursed \$161,000 from Outagamie and Winnebago County's share of \$161,000 being reimbursed from a subsequent bond issue.

**RESOLUTION NO. 384-32010: Authorize the Expenditure of up to \$1 million for the Replacement of the Finance and Payroll / HR Software, to be Funded from a Bond Issue**

WHEREAS, the Finance Department has been using PeopleSoft for its accounting applications since it was purchased in 1998; and

WHEREAS, the cost to continue to install upgrades and fixes to the software has exceeded the benefits of the improvements; and

WHEREAS, the version of PeopleSoft being run for the finance applications has not been upgraded since it was installed in 1998; and

WHEREAS, the current system is no longer supported; and

WHEREAS, the County is now at risk because of potential computer viruses that could force an upgrade operating systems software; and

WHEREAS, there is a possibility that this old version of PeopleSoft may not operate if new operating system software is installed or other patches are installed to protect against or repair the systems due to viruses; and

WHEREAS, the County is at risk of significant delays should the financial systems fail; and

WHEREAS, the County has realized savings of \$520,000 over the past seven years as a result of not paying maintenance costs on new financial applications; and

WHEREAS, the payroll and human resources (HR) applications would be reviewed during the procurement process for possible replacement due to the complexity of performing upgrades with the current PeopleSoft products; and

WHEREAS, the payback period if the systems are replaced is approximately 6 years.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates up to \$1 million to the replacement of the PeopleSoft applications.

BE IT FURTHER RESOLVED that funds to pay for said software replacements be transferred from the General Fund of Winnebago County to the Financial and Payroll / HR Capital Project fund with the General Fund being reimbursed from a subsequent bond issue.

**RESOLUTION NO. 385-32010: Appropriate \$88,000 to a Project to Purchase and Implement a Central Dictation System and Fund Using General Obligation Bond Proceeds**

WHEREAS, dictation equipment throughout Winnebago County is becoming old and obsolete and parts for equipment are difficult to find; and

WHEREAS, the Human Services Department often has to send tapes through the interoffice mail to get them from the Neenah office to the Oshkosh offices for transcription which poses confidentiality risks; and

WHEREAS, a central dictation system allows users to dictate using phones or hand held devices which can be put on a docking station and the information is quickly transferred to a network storage device where transcription can quickly take place; and

WHEREAS, a central system eliminates most of the potential risk of loss of confidentiality; and

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$88,000 to a project to replace current dictation equipment with a central dictation system.

BE IT FURTHER RESOLVED that funds to pay for a central dictation system be transferred from the General Fund of Winnebago County to a Capital Project fund to purchase and install a central dictation system with the General Fund being reimbursed from a subsequent bond issue.

**RESOLUTION NO. 386-32010: Accept Transportation Aids Funding of \$160,000 and Appropriate to the County Highway K Bridge Reconstruction Project.**

WHEREAS, during 2008, the County Board of Supervisors approved the CTH K Bridge project in the Town of Eureka over the Fox River and appropriated \$40,000 for initial design and engineering work; and

WHEREAS, the Highway Department recently received \$160,000 of transportation aids to be applied to this project; and

WHEREAS, these funds would be used for continuation of design work for the bridge and the remaining funds would be applied to the bridge construction project; and

WHEREAS, most of the \$1.4 million of construction will take place during 2011, with the County share being roughly \$280,000 and the balance of \$1,120,000 coming from Federal and / or State funding; and

WHEREAS, it would be prudent to accept the transportation aids of \$160,000 from the State of Wisconsin and apply them to the continued design work on the project with any unspent funds being added to the construction fund.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Highway Department to accept the \$160,000 of transportation aids from the State of Wisconsin and appropriate those funds for continuing design work upon the County Highway K construction project.

**RESOLUTION NO. 387-32010:      Transfer \$26,100 to Sheriff's Department's 2009 Regular Pay Budget to Cover Remainder of Cost Overrun During 2009**

WHEREAS, the Sheriff's Department has a balance exceeding budget in its 2009 regular pay account of \$26,100; and

WHEREAS, the labor contracts give the employees the right to cash in unused vacation; and

WHEREAS, the cashing in of unused vacation time resulted in a \$26,100 cost overrun; and

WHEREAS, the Sheriff Department's total variance from adopted budget in labor costs for 2009 was just 1.8% over budget; and

WHEREAS, this 1.8% overage is relatively small considering that Department's total labor budget (wage and fringe) for 2009 of \$15,598,000; and

WHEREAS, there are so many variables that can occur during a year that to be within 1.8% of budget is a considerable achievement.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$26,100 to the Sheriff Department's 2009 regular pay budget to cover the remaining overage for 2009.

BE IT FURTHER RESOLVED that funds to pay for said overage will be transferred from the General Fund Undesignated Fund Balance.

**RESOLUTION NO. 389-32010:      Increase Regular Pay Account of Register of Deeds 2009 Budget by \$8,240 and Increase Professional Services Account by \$2,312 to Cover Unanticipated Overages During 2009**

WHEREAS, the Register of Deeds office has exceeded its regular pay budget for 2009 by \$8,240 due to mis-estimates in the budgeting process; and

WHEREAS, the department has also exceeded its 2009 budget for professional services by \$2,312 due to higher than anticipated usage of the Fidler Imaging System; and

WHEREAS, the maintenance contract for the Fidler System calls for a fee based on customer usage and the usage exceeded what was projected, resulting in the overage; and

WHEREAS, it would be prudent for the County Board to transfer the funds necessary to cover these overages as part of the year end process of closing the County's books.

**RESOLUTION NO. 394-32010: Application for Aids from Wisconsin Department of Natural Resources to Assist in Breakwall Restoration As Well As Dock and Shorewall Replacement Projects at Osh-O-Nee Boat Landing**

WHEREAS, Winnebago County is responsible for maintaining seven launch facilities that enable citizens to operate boats on area lakes and rivers; and

WHEREAS, Winnebago County recognizes that properly maintained launch facilities are necessary for safe recreational boating; and

WHEREAS, it is apparent that the harsh conditions prevalent at the Osh-O-Nee Boat Landing have brought about the deterioration of 110 feet of shorewall as well as a 40 foot wooden dock located in the launch area; and

WHEREAS, within the harbor area that lies to the east of the boat launch, a significant amount of sediment and rock material has accumulated and has begun to impede the flow of boat traffic going in and out of the launch site; and

WHEREAS, financial assistance, often in the form of matching grant funds, may become available from the Wisconsin Department of Natural Resources and the utilization of these funds would help off-set costs related to restoring the rock material to the harbor breakwall as well as replacing the boat landing shorewall and wooden dock structures; and

WHEREAS, Winnebago County has a balance in excess of \$200,000 available in its Boat Trailer Parking Permit Program intended to function as the funding source in meeting the County's obligation for providing the estimated \$59,000 in matching funds needed for this project; and

NOW, THEREFORE, BE IT RESOLVED, by the Winnebago County Board of Supervisors that the County Executive be and he hereby is authorized to submit an application, on behalf of Winnebago County to the Wisconsin Department of Natural Resources for such funding aids as may be available.

WHEREAS, should Winnebago County use a dedicated connection between its network and Summit House through a multi-year contract with AT&T, the month-to-month rate will be less than what it is currently with Time Warner Cable and the connection, based upon past experience, should provide better service.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Information Systems Department to enter into a three-year contract with AT&T on similar terms that it has with that corporation for other leased lines, so as to provide a leased line connection between Summit House and Winnebago County's computer and telephone network.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Executive and Winnebago County Clerk to execute a ground lease between Winnebago County and Randy & Teresa Novak for property owned by Winnebago County which is located at Wittman Regional Airport which is approximately 5,940 square feet in size, and as is described in the proposed lease agreement, which is herewith incorporated by reference, for a term of twenty (20) years at an initial rate of \$.13 per square foot or \$550 per year, whichever is greater. A copy of the complete lease agreement may be obtained upon request from the Airport Director or the Office of Corporation Counsel. The lease shall commence on December 1, 2009 and shall run through November 30, 2029.
