5. **Presentation** – Shangri La Master Plan – Adam Breest – Parks Director

Adam Breest gave an overview of the Shangri La master plan. The Parks Department has owned property for about 25. The plan is to add walking trails and boardwalk out to the lake. Phase one would tentatively include access to the forested area, parking, lighting, walking trail, and viewing platform. Estimated base cost for phase one is about \$288k.

6. **Discussion/Action –** WI DNR Annual Snowmobile Grant 2023-2024

Every year the Parks Department needs to pass a resolution allowing the department to apply for a snowmobile maintenance grant with the Wisconsin Department of Natural Resources. Steve Binder made a motion to request authority to apply for and accept funds for maintenance of County-owned and leased snowmobile trails. Josh Belville seconded. Motion carried 5-0.

7. **Update** – Netzer Property Home Request to Purchase

Adam Breest gave an update on the Netzer property. Getting pricing for removal of home and utility disconnections. Hopeful it will be removed by fall.

8. Update – Parks Director on Potential International Pyrotechnics Guild (PGI) Conference

Adam Breest gave an update on the PGI Conference. Members of the PGI planning group will be here at the end of this week to do a walk-through and finalize a contract.

9. Parks Director Update:

Signed contract with MSA for comprehensive outdoor rec plan. Working on RFP for removing trees at Black Wolf and engineering services at Waukau Dam. Recruiting summer staff and a park ranger – have two seasons starting soon. Adam is going to Park and Rec Summit in April. Shelter rental fees will be on the April County Board agenda. Stacy got her CDL. Parks Department is working on switching to 9-hour shifts. Deerfest is coming back to Sunnyview in July. Off-road race might be coming to Sunnyview, no signed contract yet. Glow-in-the-dark egg hunt is almost sold out.
