The free app shares local resources around substance use that is available for people in Winnebago, Outagamie, and Calumet counties. To download or find out more information go to: www.weheartyou.org/app. We also have posters available if people want to post it within their organization, just contact Jennifer at jskolaski@winnebagoountywi.gov. • The Solutions Peer Response Team finished their 6 month pilot and has had amazing success, which you'll hear about in their presentation. We're excited to continue supporting such a great program and thinking of expansion opportunities including having formal partnerships with Probation and Parole, Gold Cross Ambulance, UW Oshkosh Police Department, and Oshkosh Police Department. has been working with the jail since September 6.

All information will be anonymous, no information shared will be attributed to any specific person. All session participants will receive dinner at the session (children included), childcare (18 months – 10 years old) if needed, and a \$35 Visa gift card. Harm Reduction/ Health Dept	<ul style="list-style-type: none"> Building partnerships with physicians to provide a direct referral for MAT and ID. HD collaborated with the DA, Human Services for areas of placement in the community. VM will house Narcan, FTS, other public health needs and educational information. We applied for 3 PHVM (Oshkosh and Neenah locations). Xylazine is now in the area, FTS distribution is decreasing- everything has fentanyl. There were 17 deaths in Milwaukee a few weekends ago and it has been said that a lot of them were Xylazine related. Xylazine test strips are available and very needed and they are very expensive. We currently don't have any funding that allows the purchase of them Working on starting up a new harm reduction coalition Presenting on harm reduction at WPHA on 5/16/23
