Until the position is filled all group counseling and one on one counseling will be stopping in Oshkosh starting in February 2024
- Staff had a very successful year with disability and pension claims in 2023. \$4.5 million in retroactive benefits were awarded to Winnebago County Veterans, which is up from \$4.3 million the year before.
- Neenah, the move is in the works; materials have been ordered, no construction has started.

- We are still gearing up for the Tri-County Veterans Expo.
