Introductions of All Members

ALL AGENDA ITEMS ARE ACTIONABLE

- A. Winnebago Waterways Program
 - a. WDNR Kickstart Grant completed in 2024. Focuses on providing assistance to Shoreland Property Owners and helps fund Katie's position Applying for additional funding for 3 years starting in 2025. Should hear about award by March.
 - b. Scheels awarded FWWA a \$1000 award as part of their Day of Giving in December
 - c. Volunteer Program Updates Chloride monitoring under way, 40 volunteers throughout the watershed are performing chloride/salt monitoring in local waterways, A winter native plant workshop was held in December with great attendance and engagement
- B. Calumet Pipe EARTS and Streambank update One EARTS is staked out and will be going in this winter, 2 more are planned. The Brothertown Creek Streambank restoration is set for construction for summer of 2024.
- C. Streambank Inventory update A streambank inventory was needed to account for additional sediment

and P from streambank erosion in the 9KE plans. The field inventory was completed in 2023, next step is interpolation through modeling to establish priority areas within each watershed for 9KE.

- D. Breakwall construction/funding update Winter weather has not been kind to us in terms of ice formation on the lakes. Unless we have an extended cold snap, it will likely not be safe to install the planned section this winter. Jim is working with funders to request extensions on those grants.
- E. Water level management update Another meeting is scheduled for February to discuss drawdown strategy. Currently, levels are higher than targets. The water levels committee with meeting a week prior to the ACOE meeting to discuss the WW programs "recommendations/comments" to ACOE for February Meeting.
- F. Climate Smart Agriculture grant update Calumet and Waushara position posted, Winnebago is looking at posting soon.
- G. Event updates
