4. 2017 Respite Data

Data wasn't being tracked in a way to easily show that it was respite vs. someone coming in to the home to help out the person and not relieving the care giver. This is being tracked differently in 2018 and will be able to have results at the end of this year.

Reminder that there is free respite service at St. Paul Lutheran Church, 200 Commercial Street in Neenah, twice a month (1st and 2nd Mondays) from 1:30pm to 3:30pm. An ADRC staff member brought her son's baseball team in their uniforms to one of these sessions. The children and the respite participants all thoroughly enjoyed themselves. Claire suggested to have a TV segment on these Respite services. Beth will check to see if they have permission (press releases). Elizabeth Jones mentioned a nationwide (very structured) music therapy program for the elderly where they

sing songs from the decades when the participants were in their younger days. She is not sure if this type of program is still in existence. Beth mentioned that high school choirs might be able to participate in this.

5. Survey Results

ADRC survey given to clients while they are being walked out of appointment. Results were compiled and presented from returned surveys. The data is from March of 2017- May 2018. Results were quite favorable and many, many positive comments submitted about the staff. State surveys were distributed through the mail this year. Not a very large sample size when compared to the amount of people served through the ADRC. One notable item included customer follow-up (22 would have liked one and did not receive it).

6. Emergency Protective Placement Facilities Update

APS services staff assisting a client with early onset dementia who is at the jail. Guardianship hearing was on a Friday at 1:00 which established a decision maker. Called around to EPP network and received a couple of no's, which prompted Brian to rethink education that they should do with these companies. They were able to place him at Elder Lodge, where they were willing to take a risk.
