- Time of Your Life Senior Expo was held Oct 9, 2017 500 attendees, 75 venders.
   Will be repeated next year.
- 24 referrals received for public health nursing visits, these are safety net services meaning needs could not be met through other agencies. Many of the referrals for mental health and substance abuse. One client had a history of frequent ER visits (upwards of 200 ER visits in a year). Since public health nurse, ER visits reduced to less than 40.
- Older Adult Collaborative Coalition invited the public to an AARP presentation of the <u>Livability Index</u>. <u>Tool to assess a community</u>, an address on its <u>livability</u> <u>based on 8 domains</u>. <u>Check out your community</u>: https://livabilityindex.aarp.org/
- o Fall Prevention updated Resource Guide (distributed)
- Winnebago County Wellness Coalition coalition for evidence based programs (like Stepping On) for aging. Funding for the project employee (coordinator) reducing. Looking for ways to bring additional funding for this positions
- Family Child Health (FCH)
  - Well over 100 new mom referrals to welcome new baby and share community resources with families.
  - Prenatal Care Coordination high risk pregnant moms are seen by a nurse to assure healthy pregnancy and delivery and prepare mom for parenthood.
  - Safe Sleep received a WalMart grant to purchase crib sheets and sleep-sacks for the Pack 'N Play's for families that do not have a safe place for baby to sleep.
- Breastfeeding Friendly (BFF) 2 more sites are almost ready for designation. Will
  continue to work on this objective in 2018.
- Worksite Wellness WCHD has become BFF and HR is planning to add BFF policy into the employee handbook for 2018.
- Communicable Disease team is working on the reduction of sexually transmitted disease, AmeriCorps employee is assisting with increasing awareness at UW-O. This age group has the highest rates of STIs.
