WINNEBAGO COUNTY BOARD MEETING TUESDAY, MARCH 17, 2009

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Locke.

The following Supervisors were present: Konetzke, Barker, Griesbach, Eisen, Ramos, Roh, Koziczkowski, Smith, Widener, Hamblin, Albrecht, Gabert, Riste, Thompson, Gearhart, Hall, Wingren, Jacobson, Norton, Warnke, Robl, Eichman, Schmuhl, Kline, Locke, Nelson, Finch, Sievert, Farrey, Diakoff, Brennand, Egan, Ellis, Rengstorf and Reinert. Excused: Lennon.

Motion by Supervisor Robl and seconded to adopt tonight's agenda with the change of order of the resolutions so that No. 161-32009, 168-32009 and 171-32009 are acted on before No. 151-32009. CARRIED BY VOICE VOTE.

PUBLIC HEARING

Jay Schroeder, 1295 North Lake Street, Neenah, expressed concern about Resolution No. 165-32009, "Authorize the Purchase of a Fire Fighting/Rescue Vehicle for Wittman Airport at a Cost of \$750,000 and Finance with Bond Proceeds" and the fact that a price is being noted before bids have been taken. Mr. Schroeder also suggested that the County Executive have a written analysis of each resolution brought before the Board.

Leah Kitz, 1317 Washington Avenue, Oshkosh, representing ARC/Winnebago County Disabilities Association, spoke about the proposed long-term family care program that the County Board will be acting on in the near future. She asked that the Board study this issue and carefully consider all aspects of this program before voting on it.

Ashley Heise, 4815 Plummers Point Road, Oshkosh, spoke to the Board about long-term family care and stated how this is a very complex issue. He offered the Winnebago County Board ARC/Winnebago County Disabilities Association's resources to help them understand long-term family care and it's implications to Winnebago County's citizens.

COMMUNICATION, PETITIONS, ETC.

Petition for Zoning Amendment from Wade R. Wara, Town of Poygan for zoning change for tax parcel no. 020-0020-04 from A-2 Floodplain to R-1 with no Floodplain for building a house with a full basement was referred to the Planning & Zoning Committee.

Petition for Zoning Amendment from Norman Pawelczyk, Town of Oshkosh for zoning change for tax parcel no. 018-0114 from B-3 to M-2 for assemblage to the adjoining parcel was referred to the Planning & Zoning Committee

Petition for Zoning Amendment from Bohn Farms, Town of Poygan for zoning change for tax parcel no. 0200129 from R-1 to R-2 for a single family subdivision was referred to the Planning & Zoning Committee.

Petition for Zoning Amendment from Gerald L. Kalbus, Town of Black Wolf for zoning change for part of tax parcel no. 004-0257 and all of tax parcel no. 004-0258 from P-1 to B-2 for a campground was referred to the Planning & Zoning Committee.

Resolution from Kewaunee County – "A Resolution Supporting Standard Enforcement of Seatbelt Law" was referred to the Judiciary & Public Safety Committee.

REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Kline reported that the Legislative Committee will meeting on Monday, March 23 @ 8:30 a.m. Supervisor Hall spoke on Resolution No. 155-32009, "Propose Use of Wireless 911 Funds to Offset State Budget Deficit" which the Board passed at their March 3 meeting. He stated that the fees addressed in this resolution that were to be returned to the customers through their wireless carriers were instead going to be moved by Governor Doyle and the Legislature from the 911 wireless fund to the shared revenue account. He stated that because the Board passed this resolution that money was removed "from our own coffers."

Motion by Supervisor Widener and seconded to approve the proceedings from the February 24 County Board meeting. CARRIED BY VOICE VOTE.

COUNTY EXECUTIVE'S REPORT

Executive Harris spoke to the Board about the federal government's program COPS. He explained that this program would pay the salary of a Sheriff's deputy for up to three years. The county is then obligated to continue that position. Executive Harris stated that he is discussing this program with Sheriff Brooks and they are looking at this position as a possible security officer at the courthouse.

Executive Harris explained that the federal government has made some changes that loosen up the requirements for stimulus funds for highway projects. John Haese, Winnebago County Highway Commissioner, is re-evaluating the county's highway projects to see if more might qualify for federal stimulus funds. Executive Harris then explained the process for applying for the federal stimulus money, the changes that have taken place in that process and what the county is doing now to re-apply for those funds.

Executive Harris spoke about Human Services' upcoming presentation on long-term family care and the proposed creation of the Lakeland Long-Term Care District. He explained that this is a proposed plan developed by Winnebago County and others and should be considered carefully. Executive Harris pointed out that if the county doesn't implement some plan on their own, at some point the State of Wisconsin may force the county into a "coalition that might not be of our choosing or of our form."

COUNTY EXECUTIVE'S APPOINTMENT

Advocap Board of Directors

Executive Harris asked for the Board's approval of his appointment of Supervisor Gearhart to the Advocap Board of Directors. Ms. Gearhart will replace Christopher Wright whose term will expire April 21, 2009. Motion by Supervisor Norton and seconded to approve. CARRIED BY VOICE VOTE.

CHAIRMAN'S REPORT

Chairman Albrecht reported that Supervisor Lennon is excused from tonight's meeting.

FIBER OPTICS CAPITAL PROJECT BETWEEN CITY OF MENASHA POLICE DEPARTMENT AND FAIRVIEW RADIO TOWER - SHERIFF MICHAEL BROOKS AND PATTY FRANCOUR, INFORMATION SYSTEMS DFIRECTOR

Sheriff Brooks explained that this project will eliminate the problems his department has been having with their public safety radio system. The current system is negatively affected by weather and accidents involving telephone poles/lines. Sheriff Brooks explained that when one agency's frequency is lost, their calls are placed on another agency's frequency which causes a lot of problems. By connecting the City of Menasha Police Department and the Fairview Radio Tower with fiber optics, they will create a "hot loop" for public safety radio and data systems. This hot loop senses if a connection is lost and re-routes information while keeping all the frequency's up and running.

Sheriff Brooks said this connection will also be important for the regionalization of radio systems with Outagamie and Calumet Counties, because it will allow Winnebago County to connect with Outagamie County's system.

Sheriff Brooks reported that the costs for this project are divided into three areas and then by various units of government. In the first area, the costs will be shared by Winnebago County, City of Menasha utilities and the Town of Menasha. In the second area, the costs will be shared by the Town of Menasha and Winnebago County. In the third area, all the costs are Winnebago County's. The county's cost in all three areas is estimated at \$251,000, plus another \$45,000 for equipment at the Sheriff's Office.

Sheriff Brooks then took questions from the Board.

PARK VIEW HEALTH CENTER RENOVATION-DISCUSSION

Mike Elder, Winnebago County Facilities Director, lead a question and answer session on the future use of the old Park View Health Center facility. Questions raised:

- Could Pleasant Acres be used for the courts and District Attorney?
 - o Mr. Elder explained that at this time, this is not been considered.
- What is the life cycle of Pleasant Acres? Will it cost less to operate this as a remodeled building versus a new building?
 - Mr. Elder stated the proposed remodeling of this building will make it less expensive to operate than the existing building. The building will be designed based on the needs of the departments, so that they can work efficiently as well.

- What does it cost the county to heat the Pavilion building where the Health Department and Second Chance are located? Where will the Health Department and the Second Chance program be located once the pavilion is closed?
 - o In February, it cost the county \$25,000 to heat the pavilion and the Pleasant Acres buildings.
 - The plan is to move the Health Department and Second Chance to the Pleasant Acres building once money is allocated for the project.

Mr. Elder explained that the plan now is to move departments from the courthouse campus that don't have a lot of interaction with the public—Information Systems, Finance Department, etc. Court-related departments would then have more space at the courthouse and the District Attorney's Office would be brought back to the courthouse campus.

- What will happen to the tunnel at the old Park View site?
 - Utilities will be removed from the tunnel and it will be permanently closed.
- Could the old Huber facility be converted to office space?
 - Because it was constructed as a detention facility, a lot of the things that are needed in an office—data ports, telephone connections, etc.—are not there. The security doors and secured areas also make it difficult to move about the building, so major, difficult renovations would need to be made to the building. Also, general feel of the building is not conducive to office space or a location for the Second Chance program.

HUMAN SERVICES LONG-TERM FAMILY CARE

Supervisor Koziczkowski stated that next month a resolution authorizing the county's participation in the Lakeland Family Care District will be brought to the Board for their approval. Tonight's presentation will explain what this program is and why it's right for Winnebago County and its residents.

Ken Stoffel, Deputy Director of Human Services, explained that the State of Wisconsin started this process as a pilot program for managed care (family care) for human services that impact the elderly and people with physical and developmental disabilities that require long term support.

Mr. Stoffel stated that moving to this type of family care model now lets Winnebago County have some control over designing it, instead of waiting and having the State of Wisconsin tell us what we have to do. Establishing family care now will also help to eliminate the waiting list for these programs in about three years. Mr. Stoffel explained that the elimination of waiting lists is a requirement of the state's family care plan.

<u>Long-Term Care Districts</u> – Mr. Stoffel explained that the county's proposal for family care includes the establishment of a long-term care district with Manitowoc and Fond du Lac Counties. He explained that long-term care districts are new units of government designed specifically for family care. Involvement in a long-term care district will enable Winnebago County to move ahead with the family care program.

Winnebago County has been working on and planning for family care for the past three years. The goal is to begin the transition to family care in July of 2010. A resolution will come to the County Board in April asking for their approval of this program. With the approval of a long-term care district, it will be "shifting the responsibility" for the primary funding of these types of services from the counties to the state and this long-term care district.

Aging and Disability Resource Center (ADRC) – Mr. Stoffel explained that establishing an ADRC is also a requirement of family care. The ADRC will assess and screen individuals and families who are seeking family care services.

Ellen Shute, Administrative Services Division Manager of the Human Services Department, explained that Winnebago County's ongoing contribution to the community aids basic county allocation will be 22%, phased in over five years. This means the county's current \$5.5 Million tax levy will be reduced to \$1.6 Million in the fifth year. That will mean an annual \$3.9 Million savings for the county after the fifth year. Ms. Shute explained that this is a financial commitment made by the State of Wisconsin based on Winnebago County's 2006 financial reports.

Bill Topel, Human Services Director, explained the benefits of family care:

- no waiting lists for services, so if someone who is eligible for care but is waiting, they will start to receive care;
- care will be delivered at a level determined by the long-term care district. It's important to be in a
 district that shares Winnebago County's philosophy for care—this aspect has been studied for
 years so that our long-term care district model will closely match Winnebago County's current
 services.

Mr. Stoffel, Ms. Shute and Dr. Topel then took questions from the Board.

ZONING REPORTS & ORDINANCES

RESOLUTIONS AND ORDINANCES

RESOLUTION NO. 151-22009: Transfer Funds to Various Departments To Cover Labor Cost Overruns For 2008.

WHEREAS, various departments including Airport, Courts, Coroner, Corporation Counsel, County Clerk, Human Resources, Purchasing, Register of Deeds, Sheriff, Treasurer, and UW Extension incurred labor cost overruns in their 2008 budgets per the attached budget transfer form; and

WHEREAS, most of the departments had sufficient funds in other line items in their Department's 2008 budgets to cover the overages; and

WHEREAS, an overall transfer of \$52,050 is needed from the General Fund Undesignated Fund balance to cover the net overage; and

WHEREAS, the total combined amount that all tax levy supported Departments were under budget is \$892,490 or just 1.26%; and

WHEREAS, because of tax levy and rate limits, labor budgets are prepared very tightly; and WHEREAS, much of the net overage is related to fringe benefits that are very difficult to predict. NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes budget transfers to cover the overages per the attached budget transfer form.

RESOLUTION 161-3200: Transfer \$315,526 from General Fund Balance to Various Accounts in the Clerk of Courts 2008 Budget to Cover Expense Account Overages and

Revenue Shortfalls.

WHEREAS, the Clerk of Courts Department consisting of the Clerk of Courts office and Court Branches have exceeded budget for 2008 in supplies, stationary, medical costs, and legal fees; and

WHEREAS, these overages were the result of under-estimating the costs and volumes of supplies used during the year as well as the amount of legal fees paid for defendants during the year as required by Statute; and

WHEREAS, various revenue accounts are under budget due partially to the US economic recession and the fact that estimating these revenue sources is a difficult task and the revenue sources can make large swings from year to year; and

WHEREAS, it is now necessary to approve these expense overages and revenue shortfalls and transfer funds to cover them.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$315,526 to the Clerk of Courts 2008 budget to cover the operations resulting from excess expenditures and revenue shortfalls per the attached budget transfer form.

RESOLUTION NO. 168-32009: Authorize Revenue and Expenses Related to Child Support Agency Contract with the Family Court Counseling Department in the Amount of

\$5,000 That Was Not Properly Reflected in the 2009 Budget.

WHEREAS, the Child Support Agency has a memorandum of understanding with the Family Court Counseling Department to provide services for 2009; and

WHEREAS, in preparing the budget, the Family Court Counseling Department netted the revenues against expenses in the budget; and

WHEREAS, the Finance Department was not aware of this when the 2009 budget was prepared; and WHEREAS, it is not a generally accepted accounting principal to offset revenues against expenses for financial reporting purposes; and

WHEREAS, the budgets now need to be adjusted to properly reflect the expenses in expense accounts and revenue in a revenue account within the Family Court Counseling Department; and

WHEREAS, the memorandum of understanding relates to a "Partners in Parenting Collaborative Project" being provided as a service from the Family Court Counseling Department to the Child Support Agency and will provide savings to the Child Support Agency of roughly \$4,400 or 44% through not having to contract out the service.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby adjusts the revenue and expense budgets of the Family Court Counseling Department's 2009 budget as follows:

RESOLUTION NO. 171-32009: Oppose Increases in Landfill Tipping Fee Surcharges and Oppose Elimination of Recycling/Solid Waste Grant Programs: (Solid Waste Board)

WHEREAS, the State of Wisconsin mandated recycling in 1990 under 1989 Wisconsin Act 35 and Wisconsin Administrative Code Chapter NR 544; and

WHEREAS, NR 544 requires Towns, Villages, Cities or Counties, hereafter referred to as "municipalities" to become Responsible Units for Recycling and as such are required to establish and pay for effective recycling programs; and

WHEREAS, the State of Wisconsin originally proposed to cost share 66% of the municipalities' costs for establishing and maintaining effective recycling programs; and

WHEREAS, the State of Wisconsin currently only reimburses municipalities for less than 30% of their residential recycling costs; and

WHEREAS, the State of Wisconsin has imposed levy limits on municipalities putting many under severe financial constraints; and

WHEREAS, since 1990, the State has taken over one hundred eleven million dollars (\$111,000,000) away from the segregated recycling fund to pay for other State programs; and

WHEREAS, the State of Wisconsin has used monies raised to support municipal recycling programs as part of a failed attempt to balance the State's budget; and

WHEREAS, Winnebago County has been on record since 2002 in opposition to non-recycling-related uses of the recycling fund; and

WHEREAS, the last State biennial budget increased landfill tipping fee surcharges on every ton of solid waste disposed of in Wisconsin (excluding high volume industrial by-products). Effective November 1, 2007, the recycling tip fee surcharge increased from \$3.00/ton to \$4.00/ton and the environmental repair fee increased from \$0.50/ton to \$1.60/ton; and

WHEREAS, the current budget proposed by Governor James Doyle seeks another increase in the landfill tipping fee surcharges, whereby, effective October 1, 2009, the recycling tip fee surcharge would increase from \$4.00/ton to \$5.00/ton and effective July 1, 2009, the environmental repair fee increase from \$1.60/ton to \$5.00/ton; and

WHEREAS, this equates to a 67% increase in the recycling tip fee surcharge and a 900% increase in the environmental repair fee since October, 2007, and these increase will be implemented in the middle of a budget year, putting increased strain on already stressed municipal budgets; and

WHEREAS, the proposed landfill tipping fee surcharge increases are coupled by elimination or reduction of grant programs serving municipalities and counties including: reduction of Basic Recycling Grants to responsible units from \$31 million/year to \$30.69 million/year; elimination of the Recycling Efficiency Incentive Grant Program, appropriated at \$1.9 million/year; elimination of the Waste Reduction and Recycling Demonstration Grant Program, appropriated at \$500,000/year; elimination of the Clean Sweep Grant Program, which funded agricultural chemical,

household hazardous and unwanted pharmaceutical collection programs, appropriated at \$1 million/year and elimination of the business waste reduction and recycling assistance program, appropriated at \$1 million/year.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it opposes increases in the landfill tipping fee surcharges, as this will place an undue burden on municipalities, and past practice has demonstrated misuse of collected funds for General Purpose Revenue and other programs.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it opposes the elimination or reduction of recycling/solid waste grant programs which will further decrease the State's cost share of mandated recycling programs and increase the potential contamination of Wisconsin's environment through improper disposal of agricultural chemicals, household hazardous waste and unwanted pharmaceuticals due to the lack of collection opportunities.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that a copy of this resolution be forwarded to Brown County, Outagamie County, Wisconsin Counties Association, the Wisconsin Towns Association, the League of Wisconsin Municipalities, the Wisconsin Alliance of Cities, those Wisconsin State Representatives and State Senators representing Winnebago County residents, the Joint Committee on Finance and Governor James Doyle.

WHEREAS, it would be in the best interest of Winnebago County to have this roadway resurfaced; and WHEREAS, resurfacing the roadway will extend its life an additional 20-25 years; and

WHEREAS, this project has been included in the County's five year capital improvements plan.

RESOLUTION NO. 158-32009: Authorize the Reconstruction of CTH Y From USH 76 to CTH A at a Cost of \$3.3 Million.

WHEREAS, CTH Y from CTH A to USH 76 has significant deterioration; and

WHEREAS, use of the road has increased significantly over the years due to the County Park and Expo facility, Coughlin building and other facilities located along the route; and

WHEREAS, reconstruction of this portion of CTH Y has been included in the Capital Improvements Program for several years but has been pushed back due to other priorities; and

WHEREAS, it would be prudent at this time to reconstruct the roadway, increase from two lane to a 48 foot wide four lane urban section which would include storm sewer and curb and gutter and will incorporate a recreational trail which will connect to the current CTH A trail; and

WHEREAS, there is outside funding available of \$1,372,000 to help cover the cost of the project.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$3.3 million from the general fund undesignated fund balance to the reconstruction project.

BE IT FURTHER RESOLVED that funds to pay for said improvements be transferred from the General Fund of Winnebago County to the CTH Y Capital project fund with the General Fund being reimbursed from the following funding sources:
