Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

# **REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS**

Supervisor Schmuhl asked that the Board members look over the brochure she placed on their desks entitled, "Back to Nature in East Central Wisconsin". She explained that this brochure is the result of the county's partnership with ITBEC and it contains a lot of recreational information about Winnebago County and the surrounding counties.

Supervisor Finch explained that the Parks Department is having a rummage sale to raise funds for various rehabilitation projects for the Parks Department. It will be held on Saturday, May 23 at the Expo Center. Supervisor Finch then thanked Patty Francour, Information Systems Director, for the adjustments her department made to after-hours options for the county's 727-4888 main number.

Supervisor Finch also stated that he will be asking the Legislative Committee to discuss H.R. 45 which is the Blair Holt Firearm Licensing and Record of Sale Act of 2009.

Supervisor Barker reported that on March 26 she attended a preview of the Communications Art Center at UW-Fox Valley, which will open in September 2009. Supervisor Barker also attended a WCA seminar called "Wind on Water" where wind mills/wind energy was discussed. She has information if anyone would like to see it.

Supervisor Koziczkowski informed the Board that the Human Services Board will not pursue drug prescription coverage with either Med One or NACo. Both organizations would require the county to enter into an exclusive contract with them.

Supervisor Koziczkowski also stated that the State of Wisconsin is looking at cutting \$59 Million from Human Services budgets across the state. These cuts will have significant impacts on the services the Human Services Department can provide to the citizens of Winnebago County.

Supervisor Kline reminded the Legislative Committee that there will be a meeting on Monday, April 27. An amended agenda for this meeting will be sent out later in the week.

Supervisor Rengstorf reminded the Board about the Drug Court graduation that will take place on Monday, April 27 at noon. He told the Board that none of the county's past Drug Court graduates has re-offended.

Supervisor Jacobson reported that the Information Systems Department held a county board supervisor e-mail/Outlook training session that was attended by two supervisors.

Supervisor Widener reported that 42 students participated in the county's scholarship program this year. This is the highest number of participants since 2002. Students from 12 high schools participated—including Xavier and Fox Valley Lutheran high schools and students that are home schooled. Nine winners were selected by three faculty members at UW-Fox Valley. Supervisor Widener thanked Rene Mehlberg of the UW-Extension Office for her help in coordinating the scholarship program.

Supervisor Widener then spoke about the engineering building project at UW Fox Valley. He explained that Outagamie County does not support the engineering study for this project that was approved by the Winnebago County Board, so that money will now be used to complete the project.

Supervisor Widener then discussed the annual report for the UW-Extension Department.

Supervisor Robl reported that as of April 16, the county Highway Department has used 72% of its 2009 winter maintenance budget. He stated that this is good news because the remaining funds should be more than adequate to cover the months of November and December.

Motion by Supervisor Robl and seconded to approve the March 3 and March 17, 2009 Winnebago County Board proceedings. CARRIED BY VOICE VOTE.

# COUNTY EXECUTIVE'S REPORT

Executive Harris thanked the Jones Sign Co. for donating their billboard for Tornado Awareness Week. Executive Harris then spoke to the Board and the public about long-term family care. He explained that the State of Wisconsin has indicated that it will convert all counties to long-term family care by 2013. Milwaukee County and possibly Dane County will be the only counties large enough to have their own "stand alone" family care districts. All other counties will be forced to combine with other counties to form these districts. Mr. Harris explained that Resolution No. 184-42009, "Creating a Long-Term Care District Comprised of Fond du Lac, Manitowoc and Winnebago Counties" is being presented tonight as part of these counties' efforts to control their "own future."

Executive Harris explained that Resolution No. 184-42009 is proposing a public model district, which will allow county representation on the district's board so the county can continue to influence policies and operations of the long-term family care district. He also explained that the creation of a long-term family care district has been studied for sometime, but it wasn't until the counties' received permission from the state that they were able to move ahead with the process.

Executive Harris explained the benefits of a long-term family care district, as well as the financial impact and addressed some of the concerns people have about such a district.

# COUNTY EXECUTIVE'S APPOINTMENTS

#### **Advocap Board of Directors**

Executive Harris asked for the Board's approval of his appointment of Supervisor Amy Gearhart to the Advocap Board of Directors. This is a two-year term which will expire on April 19, 2011. Motion by Supervisor Kline and seconded to approve. CARRIED BY VOICE VOTE.

#### **Affirmative Action Commission**

Executive Harris asked for the Board's approval of his re-appointments of Supervisors David Albrecht and Nancy Barker and Linda Mingus and Joaquin Lira to the Affirmative Action Commission. These are three-year terms that will expire April 17, 2012. Motion by Supervisor Robl and seconded to approve. CARRIED BY VOICE VOTE.

## **Commission on Aging**

Executive Harris asked for the re-appointments of Esther Walling, Roger Jaeger and Supervisor Donald Griesbach to the Commission on Aging. These are three-year terms that will expire on April 17, 2012. Motion by Supervisor Finch and seconded to approve. CARRIED BY VOICE VOTE.

#### Winnebago County Housing Authority

Executive Harris asked for the appointment of Richard Schallert to the Winnebago County Housing Authority. Mr. Schallert will replace Larry Schuster whose term expired. This is a five-year term that will expire on April 15, 2014. Motion by Supervisor Norton and seconded to approve. CARRIED BY VOICE VOTE.

# Local Emergency Planning Commission

Executive Harris asked for the re-appointments of Peter Running and Scott Jones to the Local Emergency Planning Commission. These are three-year terms that will expire on April 17, 2012. Motion by Supervisor Smith and seconded to approve. CARRIED BY VOICE VOTE.

### Solid Waste Management Board

Executive Harris asked for the re-appointment of Patrick O'Brien and Supervisor Paul Eisen to the Solid Waste Management Board. These are three-year terms that will expire on April 17, 2012. Motion by Supervisor Robl and seconded to approve. CARRIED BY VOICE VOTE.

# **Tri-County Recreation Association Board of Directors**

Executive Harris asked for the appointment of Supervisor Tena Riste to the Tri-County Recreation Association Board of Directors. Ms. Riste will fill the unexpired term of John Gilchrist whose term will expire April 20, 2010. Motion by Supervisor Finch and seconded to approve. CARRIED BY VOICE. VOTE.

# **COUNTY BOARD CHAIRMAN'S REPORT**

Chairman Albrecht reported that Supervisors Hamblin and Farrey are excused from tonight's meeting. Chairman Albrecht reminded the Board that they need to fill out and sign the county's vehicle usage agreement before they can have their mileage reimbursed.

Chairman Albrecht thanked Supervisor Widener for his donation to Park View Health Center.

Chairman Albrecht introduced Mary Ann Mueller, the Assistant Winnebago County Corporation Counsel. Ms. Mueller will be the county's legal counsel at the Board's meeting in May.

# DENNIS O'LOUGHLIN, PRESIDENT, WISCONSIN COUNTIES ASSOCIATION (WCA)-WCA UPDATE

Dennis O'Loughlin, Dane County Board Supervisor and President of the Wisconsin Counties Association, explained that his goal as President of WCA is to visit as many counties in Wisconsin as possible. It's been a very "enlightening" experience as he learns the various issues that counties face around the state.

Mr. O'Loughlin commended Mark O'Connell, Executive Director of WCA, and his staff in Madison for their hard work and dedication. He stated that the WCA's lobbying team is at the state capitol every day watching out for Wisconsin's counties.

Mr. O'Loughlin stated that it's been his privilege to serve as a County Board Supervisor in Dane County for the past eleven years. Since becoming a supervisor, their Board was reduced from 41 to 37 members. Mr. O'Loughlin explained that they will look again at possibly reducing their size, but not until after the federal census has been completed.

Mr. O'Loughlin stated that another one of his goals as WCA President is to promote The Wisconsin Way, which is an organization designed to get the public involved "in a continuing public conversation about modernizing and refining taxes and government in Wisconsin." (Quote is taken from The Wisconsin Way website.) Mr. O'Loughlin feels The Wisconsin Way is the "key" to positively affect the "paralysis in Madison."

Mr. O'Loughlin explained that another one of his goals as WCA President is underway and that is to create a health and wellness committee. This committee will look as various issues that people need to address to stay healthy—nutrition, exercise, etc.

Mr. O'Loughlin reported on the establishment of a WCA committee called the Constitution & Bylaws Committee. If approved, other elected officials—sheriff's, county treasurers, county clerks, etc.—will be invited to serve on this committee and get more involved in the WCA.

Mr. O'Loughlin stated that because of revenues generated by the WCA's affiliation with other organizations, they do not anticipate an increase in counties' dues any time soon.

Mr. O'Loughlin then explained the Boston Mutual Life Insurance Employee Life Option Plan that Dane County offers their employees. He stated that this is a wonderful program that helps county employees and their families who are having difficulties getting life insurance obtain a life insurance policy. Boston Mutual Life Insurance handles all the paper work, so there is no extra work required by county personnel.

Mr. O'Loughlin stated that the WCA is also working with the League of Municipalities, National Association of Counties (NACo) and the National League of Cities to establish, "a joint powers authority with the ability to issue tax exempt bonds in Wisconsin under Wisconsin law and also make the financing vehicle available to cities, counties, schools and other governmental entities across the country." He stated that the necessary legislation to make this happen is also being worked on right now. Mr. O'Loughlin stated that this would be a "tremendous" revenue source for the WCA and that they are in "pretty good shape" to get this finalized.

Mr. O'Loughlin thanked Chairman Albrecht for giving him the opportunity to speak to the Board.

# **RESOLUTIONS AND ORDINANCES**

### RESOLUTION NO. 184-42009: Creating a Long-Term Care District Comprised of Fond du Lac, Manitowoc and Winnebago Counties

WHEREAS, the State of Wisconsin has authorized expansion of the long-term care program known as Family Care; and

WHEREAS, the goal of the Family Care program is to improve people's lives through:

• Choice – Giving people better choices about the services and supports available to meet their needs

- Access Improving access to services
- Quality Improving quality through a focus on health and social outcomes

• Cost-effectiveness – Creating a system where planning for resources and options to meet an individual's outcomes also considers the comparative costs of those options and resources; and

WHEREAS, the intent of Family Care is to eliminate waiting lists for people eligible for home and community-based long-term care services; and

WHEREAS, Section 46.2895 of the Wisconsin Statutes provides counties with the legal authority to create new public entities known as Long-Term Care Districts to provide the Family Care benefit through the operation of a Managed Care Organization (MCO); and

WHEREAS, a Long-Term Care District is created by counties via resolution but operates independently of counties and therefore imposes no financial or legal liability upon the counties that form the district beyond the Basic County Allocation (BCA) percentage outlined in current state law; and

WHEREAS, s. 46.281(4) of the Wisconsin Statutes provides that the initial annual contribution of a county offering the Family Care program for the first time shall be no more than the amount that county spent on long-term care services for the Family Care target populations in 2006, and if that amount exceeds 22 percent of a county's BCA, the amount shall be decreased to 22 percent of BCA over a five-year period; and

WHEREAS, once it is officially formed, the Long-Term Care District, which includes Fond du Lac, Manitowoc and Winnebago counties, will be required to submit a response to the State's Request for Proposals for an MCO to provide the Family Care benefit in those counties; and

WHEREAS, the Long-Term Care District service model retains public oversight of an MCO through the appointment of a governing board by the participating counties.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that:

1. This document is intended to serve as the enabling resolution required under s. 46.2895(1) to form a Long-Term Care District.

2. Winnebago County declares that a need exists for a Long-Term Care District to provide long-term care services to older persons and adults with physical and developmental disabilities in this region through an MCO.

3. The purpose of the Long-Term Care District is to operate an MCO under s. 46.284 to provide the Family Care benefit.

4. The Long-Term Care District Governing Board shall be comprised of nine voting members, of which three members will be appointed by each of the participating counties. Each County will appoint at least one member representing the target populations served by the MCO. All of the members shall be appointed by the County Executive with approval by the County Board. Each county will appoint county residents who reflect the ethnic and economic diversity in the jurisdiction of the Long-Term Care District and who may not have a private financial interest in or profit directly or indirectly from any contract or other business of the Long-Term Care District. The Long-Term Care District Governing Board shall have the ability to exercise the powers and duties granted herein and by s. 46.2895 of the Wisconsin Statutes only upon the appointment of all members as provided herein.

5. The members of the Long-Term Care District Board shall serve staggered three-year terms. Of the members first appointed from each county, one shall be appointed initially for one year, one shall be appointed initially for two years, and one shall be appointed initially for three years. The initial terms for each original member shall be outlined in the bylaws of the district and such initial terms shall be communicated to the participating counties.

6. This resolution has been prepared pursuant to s. 46.2895 and creates the Long-Term Care District to operate in compliance with all requirements set forth in such statute.

7. A copy of this resolution will be sent to the secretaries of the state departments of Administration, Health Services and Revenue as required under s. 46.2895(1)(a)2.

8. This resolution and Long-Term Care District shall be effective only if the counties of Manitowoc and Fond du Lac pass a resolution in form substantially similar to that set forth herein, the legal effect of this resolution being absolutely contingent upon such action.

#### **RESOLUTION NO. 177-42009: Support Increase in Tax Deductibility Rate for Charity Drivers**

WHEREAS, on January 15, 2009, Representative Thomas Petri introduced legislation to increase the tax deductibility rate for charity drivers from \$.14 a mile to \$.55 a mile; and

WHEREAS, said rate has not been increased for many years, despite the fact that gas prices have more than doubled since the time that said rate was established; and

WHEREAS, the Legislative Committee of the Winnebago County Board of Supervisors believes that the Charitable Driving Tax Relief Act sponsored by Thomas Petri is in the best interest of citizens of Winnebago County.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby supports the passage of the Charitable Driving Tax Relief Act as proposed by Representative Thomas Petri.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby directs the County Clerk to transmit a copy of this resolution to Congressman Thomas Petri and to Senators Herbert Kohl and Russell Feingold and to the Wisconsin Counties Association.

#### RESOLUTION NO. 178-42009: Support Spending of Federal Economic Renewal Grants on American Products

WHEREAS, the economic downturn is having a critical impact on everyday Americans who are struggling to maintain or find jobs in an increasingly difficult environment; and

WHEREAS, those same Americans are the taxpayers that provide the revenue needed to operate essential government services; and

WHEREAS, Congress and President Obama are planning a taxpayer-sponsored economic recovery package that will provide billions of dollars to assist economically devastated cities and states so as to immediately provide jobs to millions of out-of-work Americans through considerable infrastructure rebuilding, green energy projects and other projects that will require manufactured components; and

WHEREAS, our taxpayer dollars should be spent to maximize the creation of American jobs and restoring the economic vitality of our communities; and

WHEREAS, any domestically produced products that are purchased with economic recovery plan monies will immediately help struggling American families and will help stabilize our greater economy; and

WHEREAS, any economic recovery plan spending should, to every extent possible, include a commitment from governmental units to buy materials, goods and services for projects from companies that are produced within the United States, thus employing the very workers that pay the taxes for the economic recovery plan spending in the first place.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that Winnebago County commits itself to work to maximize the creation of American jobs and restore economic growth and opportunity by spending economic recovery plan funds on products and services to the greatest extent possible, that will both create jobs and help keep Americans employed.

WHEREAS, the Winnebago County contribution that is used to supplement the Medical Assistance funding for the care of Park View Health Center residents is used by the State of Wisconsin to capture federal supplemental payments for the State Medical Assistance Program; and

WHEREAS, a significant portion of the supplemental payment funds are used by the State for the Medical Assistance Trust Fund, and are not fully returned to Winnebago County; and

WHEREAS, 2005 Wisconsin Act 107 (205 AB 802) requires that any revenue generated based upon county nursing home losses above the amounts contained in the State Budget must be paid to county nursing homes; and

WHEREAS, in 2009, this payment amount would equal to approximately \$630,000 in payments to Park View Health Center; and

WHEREAS, the proposed State Budget increases the nursing home bed tax by \$75.00 per bed per month in fiscal year 2009-2010, and by \$95.00 per bed per month thereafter in order to fund a 2% rate increase, but appropriates two-thirds of this bed tax to the Medical Assistance Trust Fund; and

WHEREAS, the proposed State Budget eliminates the nursing home appeal fund from which \$45,000 was budgeted to Park View Health Center in 2009.

WHEREAS, Senate Bill 107 has been introduced in the Wisconsin legislature as an act relating to the sale, disposal, collection, and recycling of electronic devices, granting rule-making authority, making an appropriation, and providing penalties; and

WHEREAS, Senate Bill 107 is consistent with the recommendations on electronic waste made by the Governor's Task Force on Waste Materials Recovery and Recycling;

NOW, THEREFORE, BE IT RESOLVED that the Winnebago County Solid Waste Management Board supports the passage of Senate Bill 107, its enactment into law in Wisconsin and the development of a segregated fund for fees collected to administer and enforce the resulting law and regulations.

# RESOLUTION NO. 196-42009: Oppose the Governor's Proposed Changes to Insurance Laws and 2009 Senate Bill 20

WHEREAS, Governor Jim Doyle's 2009 Executive Budget Bill (2009 Assembly Bill 75) contains several anti-tort reform proposals including, but not limited to:

- Changing comparative negligence laws to force a defendant to pay one hundred percent of the damages when they have as little as one percent of liability;
- Forcing individuals, companies and local governments to pay for higher levels of insurance by increasing mandatory minimum auto liability insurance limits;
- Changing the definition of an "underinsured motorist" in a way that increases insurance claims;
- Requiring insurance companies to cover "uninsured motorist" insurance claims when no contact
  was made between the insured's car and another car, thereby increasing the risk of fraudulent
  claims;
- Allowing "stacking" of coverage for "underinsured motorists" such that the coverage limits for an accident are not limited to the policy relating to the particular vehicle involved in the accident;
- Forcing excess or umbrella insurers to offer to cover certain claims when the coverage was not
  requested by the insured; and

WHEREAS, the aforementioned anti-tort reform proposals would significantly increase the cost of providing insurance in Wisconsin; and

WHEREAS, Winnebago County currently procures its liability insurance through Wisconsin County Mutual Insurance Corporation (WCMIC); and

WHEREAS, WCMIC is a county owned and operated mutual insurance company created for the purpose of providing long-term stability in insurance coverage and insurance costs for counties; and

WHEREAS, as a mutual insurance company, WCMIC's increased cost of providing insurance resulting from the anti-tort reform proposals would be borne by counties and their taxpayers directly in the form of increased insurance premiums; and

WHEREAS, 2009 Senate Bill 20 is currently pending before the Senate Labor, Election and Urban Affairs Committee; and

WHEREAS, Senate Bill 20 would have a dramatic financial impact on counties by changing employment discrimination laws as follows:

- Allowing claimants to collect unlimited punitive damages against counties contrary to current state and federal law;
- Forcing counties to pay a punitive 10% surcharge to the court system in addition to unlimited damages;
- Forcing counties to litigate issues of compensatory and punitive damages years after the initial discrimination complaint was filed.
- Creating an irrational and inefficient complaint process where both parties have an incentive to litigate claims to the fullest extent possible; and

WHEREAS, Winnebago County faces significant budgetary challenges related to the provision of critical state and county services at a time when state and federal financial support for such services is decreasing and the burden placed on Winnebago County taxpayers is growing; and

WHEREAS, adding new costs for counties and forcing counties to increase their tax levies during our current economic downturn would be devastating to property taxpayers who can ill afford increased taxes or increased insurance costs;

NOW, THEREFORE, BE IT RESOLVED, that the Winnebago County Board of Supervisors hereby opposes the Governor's proposed changes to insurance laws included in his 2009 Executive Budget and the proposed changes to employment discrimination laws in 2009 Senate Bill 20 and strongly encourages its senators and representatives in the Wisconsin State Legislature to reject the Governor's proposals and Senate Bill 20.

WHEREAS, 60 to 80 percent of drug offenders sentenced to prison and over 40 percent sentenced to probation recidivate, and whereas fewer than 17 percent of Drug Court Graduates recidivate; and

WHEREAS, results of more than 100 program evaluations and at least four met analytic studies have yielded definitive evidence that Drug Courts are demonstratively effective and significantly improve substanceabuse treatment outcomes, substantially reduce drug abuse and crime, and do so at less expense than any other justice strategy; and

WHEREAS, over 25,000 judges, prosecutors, defense attorneys, substance abuse and rehabilitation professionals, law enforcement and community supervision personnel, researchers and educators, national and community leaders, and others dedicated to Drug Courts and similar types of treatment programs are healing families and communities across the country; and

WHEREAS, the Drug Court movement has grown from the 12 original Drug Courts in 1994 to 2,301 operational Drug Courts and 3,410 problem solving courts as of December, 2008; and

WHEREAS, the Winnebago County Safe Streets Committee started a Drug Court here in Winnebago County on January 1, 2006; and

WHEREAS, Friday, May 15, 2009 marks National Drug Court Commencement Day, which celebrates the promise of recovery and restored hope to Drug Court graduates and their families.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby declares that a "Drug Court Month" be established during the month of May, 2009, recognizing the practitioners and participants who make drug courts work and the significant contributions that Drug Courts have made, and continue to make, in reducing drug usage and crime in Winnebago County and across our nation.

WHEREAS, through comments solicited from boaters who frequent the Poygan Boat Landing, it has become evident that there is a need to better service activities at the site by putting in place the same type of seasonal dock currently in use at several of the other County boat landings; and

WHEREAS, Winnebago County has a balance in excess of \$200,000 available in its Boat Trailer Parking Permit Fee Program; and

WHEREAS, with the cost of the Lake Poygan Boat Landing improvements estimated at \$128,000, it is appropriate to utilize the Boat Trailer Parking Permit Fee Program as the funding source in meeting the County's obligation for providing the \$64,000 in matching funds needed for these projects; and

NOW, THEREFORE, BE IT RESOLVED, by the Winnebago County Board of Supervisors that the County Executive be and he hereby is authorized to submit an application on behalf of Winnebago County to the Wisconsin Department of Natural Resources for such funding aids as may be available.

WHEREAS, a recent ice shove on Lake Winnebago damaged a sizeable portion of the south dock located at the Osh-o-Nee Boat Landing; and

WHEREAS, because of the high degree of boating activity that is common at the site, it can be anticipated that the absence of any docking space will cause a great deal of inconvenience for parties who elect to use the Osh-O-Nee Boat Landing; and

WHEREAS, in order to avoid possible conflicts that may arise at the boat landing, it would be appropriate to attempt to replace the damaged dock with a portable seasonal dock at an estimated cost of \$15,000; and

WHEREAS, it may be possible to defray up to \$5,000 of the expenses involved in the dock replacement project through funding assistance made available from the Wisconsin Department of Natural Resources.

NOW, THEREFORE, BE IT RESOLVED, by the Winnebago County Board of Supervisors that the County Executive be and he hereby is authorized to submit an application on behalf of Winnebago County to the Wisconsin Department of Natural Resources for such funding aids as may be available to engage in a dock replacement project at Osh-O-Nee Boat Landing.

BE IT FURTHER RESOLVED by the County Board of Supervisors of the County of Winnebago that Appendix "A" of Chapter 11 of the General Code of Winnebago County shall become effective on July 1, 2009.
