Including: Discussion on the need to provide counseling services to at risk youth in alternate school settings.

Need for yearly screenings in all grade levels.

Need for resources for Parent and Youth group leaders including how leaders can be supportive to those affected by suicide.

Discussion about increasing communication between Human Services, CPS, primary providers, law enforcement, mental health providers and schools to facilitate advocacy for services to at risk children when parents are resistant to those services. A sub-committee may convene in 2019 to discuss this.
