Steering Committee Updates: We have 5 out of the 7 positions filled. More information about the role of the Steering Committee is provided on the top of the form. We are moving ahead with the 5 names we have – they will be provided to the County Executive for official appointment at the May County Board meeting. Per the by-laws, the Steering Committee terms are to begin in June.

- Extension has promoted the Steering Committee openings on their social media and email newsletters for the last six weeks.
- Rest of group is encouraged to continue advertising the open positions as part of your role on this collaborative team.

Event Announcement: Waking Up White Viewing – The group should have received a copy of the flyer by email. Beth Roberts will be using a facilitated discussion guide for the guided discussion that is following the video viewing that has been published to use with book reads, etc. Participants can join for the video viewing or watch on their own and join for the discussion only.

Development of By-Laws: By-laws are still in draft format as the Mission Statement is still being developed. The draft includes the updates suggested at the April Meeting. Mandi Dornfeld (Extension Liaison) has been assisting with the editing of this document.

- By-laws include wording to match the wording of the County Board resolution.
- The purpose of the by-laws are to lay out how you're going to run your Commission. They should be written to
 reflect this group's decisions about how to operate within the parameters set by the County Board
 The Observation County Board
- The Steering Committee will be made up of the Officer Positions.
- The Extension Liaison and Community Liaison will be utilized as needed (to be determined by the Steering Committee). The Liaison positions are not appointed positions.

This is the second month that the group has been working on the by-laws. Once completed, this document will be presented to the County Board along with the Strategic Plan for approval.

Strategic Planning – Mission Statement: Heidi Keating (Winnebago County Health Department) facilitated group discussion to develop the Commission's mission statement. Notes from brainstorm / discussion about mission May 6, 2021 provided by Heidi Keating, facilitator:

Why does the DA Commission exist?

- To pursue equity among a diverse county
- All of our residents have an opportunity to thrive (good education, good job, college, opportunities-home ownership
- Purpose of Organization is to create an equitable and inclusive Winnebago County (result) that fosters thriving communities for all who reside and work in Winnebago County. (from bylaws)
- Diversity is a strength and use to county's advantage, to realize there is strength in diversity, diversity benefits everyone
