5. Consideration (Vote): Purchase of a microwave network equipment that will replace existing Cambium microwave network equipment that is reaching end of life and will no longer be supported by the vendor; Cost \$360,200.00- Sheriff John Matz

This equipment allows for surrounding agencies to be able to communicate with each other through the radios. The current equipment is reaching end of life and need to be replaced.

*Sheriff Matz discussed the COVID-19 testing that took place within our jail as well as answered a committee members question regarding vaccines coming to Sheriff's Office members.

*Sheriff Matz responded to a committee members question regarding sending Sheriff's Office members down to Kenosha. Sheriff Matz indicated the Sheriff's Office sent 8 SWAT Team members and 1 supervisor down but they were sent home early as there were no major issues.

*Sheriff Matz responded to a committee members question regarding a 980 Offender update. Sheriff Matz indicated they still had not heard back from the City as to whether or not the trailer can have double occupancy but if it's approved, he would still like the newest offender housed at the trailer and that offender is currently housed at the Wolf River address.

*Sheriff Matz responded to a committee members question regarding ice conditions. Sheriff Matz stated the ice on any lake is not safe right now and we have had to do at least one vehicle rescue off of the lake.

Supervisor Schorse would like an update on the Connect Program and would like a member from the District Attorney's office as well as Human Services present.
