5. Discussion/Action: Amend County ordinance relating to City of Neenah and Town of Neenah supervisory district boundaries as a result of City annexation – John Bodnar

John Bodnar stated the amendment is within the existing ordinance. Currently there is no one living on the property that was annexed so the amendment is to fix the boundaries in District 9 and District 10 before the property starts to be developed.

Paul Eisen discussed the description of the ordinance regarding the district boundaries and how it was not clear what the change is to the ordinance. Bill Roh stated he did not want to amend the ordinance right now with there being some confusion regarding the amendment.

After a more in depth discussion between John Bodnar and the committee, it was decided to send the ordinance back to Corporation Counsel for a more in depth meets and bounds description. It will be brought back to Judiciary in July for further review.

6. Sheriff's Report

Todd Christopherson stated the special events kick off today starting with Country USA.

Todd Christopherson reviewed a press release that was published on June 1st regarding the Narcan the deputies now carry with them. June 5th was the 1st deployment with the Narcan. The Sheriff's Office obtained 96 doses and the price for 96 doses is \$3,600. The Health Department used a State of Wisconsin Grant so the Narcan was provided to the Sheriff's Office free of charge through the grant.

Todd Christopherson reviewed an armed robbery in the Town of Menasha. The subject took off in a vehicle and a Sheriff's Office deputy spotted the vehicle and a high risk traffic stop was performed. While our deputies were taking control of the suspect, two lanes of HY 41 were shut down and one of the Sheriff's Office squads was hit and totaled due to an inattentive driver. No one was injured.

Paul Eisen asked Todd Christopherson to give a review the Awards Ceremony that was held on May 19th, 2016.

Paul Eisen asked Todd Christopher to explain the change of structure within the department regarding the Captain movement effective June 20th, 2016.

Bill Roh asked Todd Christopherson for the current year to date Budget report. They will be mailed out to committee members later this week once they are available on the 10th business day of the month.

Paul Eisen asked Todd Christopherson to give a review of the Use of Deadly Force General Order.
