1. Call to Order

Chairman Wingren called the meeting to order at 9:00 a.m. and it was verified that the meeting was properly noticed.

2. Presentation and explanation of Winnebago County redistricting maps by Jerry Bougie, Adam Dorn and Diane Culver of the Winnebago County Planning & Zoning Department.

Jerry Bougie started the presentation by explaining the stages needed to make the maps. There needs to be equal population, Minority Protection, Contiguity, Compactness, Preservation of Communities of Interest and Preservation of the Unity of Political Subdivisions.

Diane Culver then presented the three options of maps and explained the differences between all of them.

3. Public comments and review of maps

County Clerk Sue Ertmer commented that map option #2 would affect voting with having multiple school districts within the new grouping.

Citizen Kathleen Popp spoke in favor of Option #1 based on the numbers.

County Executive Jon Doemel likes what the Planning & Zoning Department has done with the mapping and stated he would support whatever option is decided on.

Supervisor Bryan Stafford asked about the impact to voting wards. Jerry Bougie responded that municipalities will create new wards based on whatever district map is chosen. Bryan also asked about the breakdown of new to current constituents and the trending consideration. Jerry Bougie explained that the numbers are given to them by the census.

League of Women Voters Ann Marshall stated she supports option #1 and then Option #3.

4. Consideration (Vote) on redistricting map or maps to be presented to the Winnebago County Board at their September 14, 2021 redistricting public hearing.

Chairman Wingren made a motion to move map options #1 & #3 to the board, seconded by Tom Ellis. Motion carried 5-0.

Supervisor Eisen asked that the benefits to each of the maps be presented at County Board by Planning & Zoning in order for the other County Board Members to make a decision on which map they like best.

5. Consideration of Minutes of August 9, 2021 meeting

A motion to approve the minutes from August 9, 2021 was made by Tom Ellis, seconded by Mike Brunn. Carried 5-0.

8. Presentation of 2022 Budget - Coroner - Cheryl Brehmer

Cheryl Brehmer presented her budget and answered any questions the committee had regarding her budget.

9. Presentation of 2022 Budget - Veteran's Department - Jeffery Bucholtz

Jeffery presented his budget and answered any questions the committee had regarding his budget.

10. Consideration (Vote): Revocable License for use of property for Readjustment Counseling Services – Veteran's Department – Jeffrey Bucholtz

Jeffery spoke about the Veteran's Department providing readjustment counseling services to Veterans and the office space for counselors to utilize when offering those services. This avoids the Veteran's having to travel to Green Bay to see the counselor.

A motion to approve the revocable license for use of property for readjustment counseling services was made by Mike Brunn, seconded by Vicki Schorse. Carried 5-0.

11. Presentation of 2022 Budget - Child Support - Julie Mabry

Julie presented her budget to the committee and answered any questions they had regarding her budget.

12. 980 Sex Offender Status Update – MaryAnne Mueller, Mike Elder, John Matz, Adam Dorn, Jon Doemel and Ethan Hollenberger

MaryAnne gave an update on the 980 offenders. MaryAnne stated they found housing 6 weeks prior to a new 980 offender being released. The Supervisor Release planned was delaying due to concerns they have on housing based on the needs of the offender. The clock will start over if the housing option is shot down based on the needs of the offender.

MaryAnne stated per Human Services, the housing option available based on the disability of the offender may not be an option for this particular offender. Other plan deadlines may have to be pushed forward as this offender can't be housed with other offenders. Another option would be to look at possibly having another trailer placed on the property of the existing trailer.

13. Consideration (Vote): Budget Transfer: Transfer excess capital funds from Patrol to Detective for the purchase of four (4) Video Processing Units/Accessories/Installation – Sheriff John Matz

Sheriff Matz stated there was no vote needed for this item as there are excess funds being transferred from Patrol to Detectives to cover the cost of the 4 new cameras. The interview rooms used by the detectives need their cameras replaced. There are enough funds to replace of the cameras.

14. Sheriff's Report

*Sheriff Matz discussed some budget changes with the elimination of some positions and sending back all contracted inmates to the state creating a wash in the budget.

*Sheriff Matz gave an update on COVID in the jail with staff and inmates.

*Sheriff Matz stated there will be a safe child exchange area in the Sheriff's Office parking lot. The parking lot is monitored by cameras so it provides a safe area for parents and children during exchanges.

*Sheriff Matz stated an after-action review from EAA was sent out to committee members.

*Sheriff Matz stated he attended and was a part of a 9/11 tribute that was conducted by Teen Court participants. He stated it was a great event and had good attendance and participation.
