1. Call to Order

Chairman Bill Wingren called the meeting to order at 9:00 a.m. and it was verified that the meeting was properly noticed.

2. Consideration of Minutes of November 12, 2018 meeting

A motion to approve the minutes from November 12, 2018 was made by Larry Smith, seconded by Tom Ellis. Carried 3-0.

Paul Eisen arrived after the voting of this agenda item at 9:01am.

3. Public comments on agenda items

4. Communications shared by Committee Members

Chairman Wingren brought forward an article in regards to Mental Health Court.

5. Consideration (Vote): Budget Transfer for \$1000.00 between the Travel and Other Operating Expenses categories to fulfill Continuing Legal Education Requirements – Corporation Counsel – Mary Anne Mueller

Mary Anne Mueller discussed the need to continue legal education and the importance of those requirements. The money will be taking from Legal Services and transferred into the Legal Education fund.

A motion to accept the budget transfer of \$1000.00 for continuing Legal Education Requirements was made by Paul Eisen, seconded by Larry Smith. Carried 4-0.

6. Discussion of Statutorily Amended Supervised Release Law pertaining to Sexually Violent Persons – Corporation Counsel – Mary Anne Mueller

Vicki Schorse arrived at the beginning of this discussion at 9:05am.

Mary Anne Mueller and Bill Topel spoke on this topic and the importance of finding a solution for housing the person being released from Sand Ridge Secure Treatment Center or Winnebago County facing fines of up to \$1,100 per day per person if housing is not provided. They stated there is a parcel of land within the county that is the only suitable option right now that follows the statute rules and regulations for the supervised person upon being released. As of now, the City of Oshkosh has already approved a mobile home to be placed onto the property for housing of the person being released but the land parcel has not been approved as of the time of this meeting. The City of Oshkosh also approved that only one person is to reside in the home at a time.

There will be a presentation to the County Board in December in regards to the law as well as more information on the possible land parcel and home placement for this individual. This could also include a vote for \$100,000 towards the residential option versus the county facing up to a \$1,100 per day fine if the housing is not provided for this individual.

7. Consideration (Vote): Ordinance: “Create Section 3.17 of the General Code of Winnebago County: Requiring the use of Parcel Identification Number (PIN) on all documents pertaining to real estate.” – Register of Deeds – Natalie Strohmeyer

Natalie stated that she would like parcel numbers on the deeds for all documents pertaining to real estate as it is required for people to know their parcel numbers and it will make it easier for everyone to have it printed right onto the documents.

A motion to approve the ordinance pertaining to General Code 3.17 requiring the use of Parcel Identification Numbers on all documents pertaining to real estate was made by Larry Smith, seconded by Vicki Schorse. Carried 5-0.

8. Sheriff's Report

-Sheriff Matz stated the jail count was at 268.

-Sheriff Matz stated the budget sheets will be available to the committee by December 14th.

-Sheriff Matz stated we currently have 6 eligible inmates that would qualify for Mental Health Court. 3 of those inmates are already receiving services.

-Sheriff Matz showed 2 videos in regards to the recent squad crash involving an OWI driver and a call for service involving an individual who had used Meth.

-Sheriff Matz presented a PowerPoint involving a couple of special investigations we were involved in that may affect our special investigations budget line item.

9. Suggested items for next agenda

Sheriff Matz would like to bring forward the No Wake Enforcement Ordinance for Little Lake Butte Des Morts.

Sheriff Matz will be bringing a Homeland Security Grant forward.
