She explained the price difference between high rise desks versus the separate ergonomic piece that sits on top of the low rise desks. It is cheaper to get the high rise desks up front rather than purchasing the separate ergonomic pieces later for on top of the low rise desks.

A motion to approve the purchase of furniture & cubicles was made by Larry Smith, seconded by Paul Eisen. Carried 4-0.

7. Sheriff's Report

- Sheriff Matz passed out a press release in regards to an overdose case that our agency investigated.
- Sheriff Matz discussed the movement of 5 out of 10 part-time jail positions to full time status. This went before the Personnel and Finance Committee and passed so it will go to the County Board for approval.
- Sheriff Matz said the jail count was 319 but reached an all time high of 366 in November.
- Sheriff Matz briefly discussed a possible jail study taking place in 2018. He stated that the Sheriff's Office is working with the District Attorney's Office, Probation and Parole and the Judges to come up with solutions to keeping the jail count down and to see if there are other solutions besides a jail expansion.
- Sheriff Matz will bring a tunnel usage report with him to the next committee meeting.
