## Review and Discuss Two Draft Section Summaries of the Winnebago Waterways Management

Plan Entitled; Shoreline Management and Habitat Management

Korin Doering, FWWA reviewed each section identifying the key elements as she went. Doering also provided lists of projects and explained the criteria that will be used to prioritize the projects on the list. Doering answered questions from the LCC and recorded their comments and suggestions. Doering stated that the last two sections would be ready for review by the end of January, 2020. In addition to the section review, Doering also elaborated on some of the implementation work that is being planned with the Sunset Bay landowners and in the Pipe Creek Watershed in Fond du Lac County. The LCC thanked Doering for her fine report and work on the plan.

# Review and Discuss the New WDNR Pilot "Aquatic Invasive Species (AIS) Coordinator Program" Provided in Partnership with the FWWA for Winnebago County

Chris Acy, FWWA reviewed the AIS accomplishments for 2019 and explained the new WDNR AIS pilot program. Acy explained that the program would allow the County to designate FWWA to coordinate the AIS efforts within the county. The WDNR would then make payments directly to FWWA on behalf of the county. The LCC was very supportive of the new pilot program. Chairman Farrey asked that approval of the program be placed on the February 13, 2020 LCC Agenda. The LCC thanked Acy for his fine work and presentation.

# Review and Approve the Proposed Revisions to the Livestock Waste Management Ordinance and the Associated Ordinance Fact Sheet and Livestock Waste Application Guidance Document

Following a brief review of the documents a Snider/Gordon motion to approve the final drafts and take them to public hearing at the February, 2020 LCC meeting passed 6-0.

## Review and Approve the Payment of the 2020 Wisconsin Land and Water Conservation Association (WLWCA) Annual Dues (\$2,036.00)

Following a brief discussion, a Gordon/Binder motion to pay the 2020 WLWCA dues passed 6-0.

# Review and Approve Winnebago County Water Quality Improvement Program Cost-Share Agreements (CSA) to Provide Funding for Eligible Projects

Following a review of the CSA summary, a Joas/Gordon motion to approve \$5,200.00 for John Lenz for a wetland restoration project and \$3,266.00 for Gregory and Stacey Thomson for a shoreline habitat restoration project and \$2,643.00 for Gerald Aggen and Deborah Rawls Young for a shoreline protection project passed 6-0.
