<u>Confirm Meeting/Agenda has been Properly Public Noticed in Accordance with County Policy:</u> Vice-Chairman Snider confirmed with Tom Davies that the meeting had been properly public noticed.

<u>Approve March 3, 2016 LCC Meeting Minutes</u>: A Kriescher/Bohn motion to approve the March 3, 2016, LCC meeting minutes passed 5-0.

Announcements:

- Tom D. informed the LCC that another Soil Health Field Day is being planned for later in the year at the Ron and Rick Gehrke Farm near Eureka.
- Tom D. mentioned that the LWCD Staff are working on a Soil Health Challenge Program to provide cost-sharing to landowners willing to implement no-till with cover crops on a portion of their farm for a minimum of five to six years. These farms would be used as educational resources to promote soil health and demonstrate the reduction in sediment and phosphorus delivery through the use of no-till planting and cover crops.
- Tom D. stated that the WPS Farm Show had good attendance and that having a staffed booth at the show was very beneficial.
- Tom D. passed out copies of the DATCP April report for LCC review.
- Tom D. informed the LCC that the LWCD was still working on the Livestock Waste Management Ordinance revisions. The LWCD will also review a new LWMO template provided by DATCP to assure Winnebago County's is legal.
- Tom D. shared that the LWCD responded to a manure runoff complaint in the Towns of Nekimi and Utica. The issue occurred on a farm located in both towns.
