Recommendations will be connected to key stakeholders in the community, we will monitor progress, and communicate challenges and/or the fulfillment of the recommendations. A formal public sharing of recommendations will be forthcoming.

Short Term Recommendations:

- Create a resource card that partners can hand out to at-risk individuals.
- Make LEAAP program happen in Oshkosh.
- Explore feasibility of police departments and fire departments mapping out overdoses and drug arrests.
- Winnebago County Health Department gives out free Narcan with training.
- Community "training" on Narcan for those overdosing who never intended to use opiates.
- Rethink or revamp chaplain program to make available visits for all overdose related incidents, as well as inmate mentoring.
- Pharmacists checking PDMP when prescriptions are distributed

Longer Term Recommendations:

- Peer support for substance use a billable item allowable by MA (medical assistance/state insurance)
- Growing LEAAP regionally
- Create a cross-county, multi-faceted approach for those at risk or drug use (e.g., similar to crisis intervention team)
- Training for those (individuals or organizations) who come into contact with people using (i.e., new first responders, e.g., faith leaders, library, bus drivers, teachers). Work with those providing CPR training to include Narcan training).
