1. William and Sheila Schultz, 128 Rickers Bay Rd-Town of Neenah-Zoning Map Amendment

Committee reviewed findings in order to take action on a zoning map amendment request from the B-1 to a R-2 zoning district to accommodate a parcel combination csm. Parcel number 010-0178-06-05.

# 2. Thompson Turf LLC, 8969 CTH II-Town of Wolf River – Zoning Map Amendment

Maribeth Gabert mentioned that the town did not have a chance to meet or submit a recommendation but the supervisors agreed this request was within their jurisdiction due to shoreland zoning and felt comfortable to proceed with their decision. Marina and storage of watercraft/recreational vehicles shall adhere to the standards set forth in Chapter 23.8-383, 23.8-402 and 23.8-295 including, but not limited to, the fencing and setback requirements for the outdoor storage area. Motion carried 5-0.

# 4. John Jungwirth – N of 1391 Leonard Point Rd–Town of Algoma–Zoning Map Amendment.

Committee reviewed findings in order to take action on a zoning map amendment request from the R-1 to the R-2 zoning district to accommodate a parcel combination CSM. Parcel number 002-0160-02-01
