1. LONNIE DARLAND – 239 Old Oregon Rd.-Town of Nekimi-Zoning Map Amendment

Owner is requesting a zoning map amendment from the R-1 District (Rural Residential) to the A-2 District (General Agricultural) and from the A-1 District (Agribusiness) to the R-1 District (Rural Residential) with the intent of executing a land exchange between an adjoining land owners and reconfiguring the parcel lines with a CSM.
