3. Discussion and possible Committee action on Sawyer Creek Floodplain study.

C. Rowe stated that the City of Oshkosh Public Works Department hired Strand & Associates to conduct a floodplain study for the purposes of locating areas to be used as flood storage for Sawyer Creek, and provided the final map as a result of the study. Strand & Associates have requested a signature from a staff member of the Planning & Zoning Department in order to submit a letter of map revision to FEMA, with a subsequent zoning change at the City and County level in order to revise the area shown as flood storage. However, in having conversations with City of Oshkosh Community Development staff it was indicated to him that none of the property owners who would be affected have nor had been notified of this proposed change. Therefore he indicated that he would be notifying the engineer requesting a signature of County staff that the document would not receive a signature from the County until such time as it can be verified that some type of public outreach has been conducted, as well as notifying each individual property owner that would be affected.

There was a consensus of the Committee that a zoning change to amend the County's floodplain/flood storage map at the County level would not be initiated until such time as the City of Oshkosh Public Works Department and/or Strand & Associates can verify the actions previously described have been conducted.

There was no further discussion of this item.

4. <u>Committee review and action to forward Town of Oshkosh, Town of Vinland, and</u> <u>Town of Utica town zoning changes to County Board</u>.
