Under this proposal, there would be the removal of the mandatory two-year waiting period to reinstate a nursing home provider's CNA training authority and the provider could be reinstated once a deficiency is corrected. The Winnebago County Board of Supervisors supported the resolution last November.

The PVHC Committee was encouraged to contact their Congressional representative, asking to sign on with H.R. 4468.

• Administrator Keuler Grahek shared the news that Park View Health Center has been named the #1 nursing facility in Wisconsin for 2020, by <u>Newsweek</u> magazine. The information was handed out to the Committee.
