PUBLIC COMMENTS:

Hannah Schmidt from ESTER Fox Valley came to support the COTS expansion in Winnebago County. Talked about homelessness and how she would like to look deeper into the issue. Will write a letter to address more. Carol Morack gave her contact information to follow up with.

PRESENTATION REGARDING POSSIBLE EXPANSION OF OUTAGAMIE COUNTY COTS AND RIVERVIEW GARDENS PROGRAM:

Cindy Sanstsky from COTS/Riverview Gardens/ RYAN House presented on what each facility offers clients.

COTS: serves homeless population. Follows clients 3 years after leaving . Recidivism rate after 3 years is 6%

RYAN House: For those who are on Parole/ ATR that are High to Medium risk and at risk to re-offend. Stay 90 -120 days in program. Also work with CCEP to gain employment while there.

River Gardens: For profit job training. Served 500 individuals in 2019. Programs include: Organic Farm, Cleaning Downtown Appleton daily, Maintenance program, corporate accounts and Aquaponics facility where they farm fish and lettuce.

OVERDOSE FATALITY REVIEW AND PUBLIC HEALTH UPDATE:

Sara from the Health Department gave update on We Heart You cards, this is 3rd year funding cards. For officers to hand out to those who are using or loved ones of those using. Phone Number on card goes to 211. Description attached.

Health Department held a Summit in August as part of their Opioid Preparedness grant.

Looking into applying for an Overdose Data to Access grant. Public Health is also working with JSS to help with program.

Re: THINK:

10 year grant is up. Have new grant that is for \$625,000 for 5 years focus is on Alcohol and Marijuana. New name: Winnebago County Drug and Alcohol

STEP UP:

Hadn't been doing for a while, started doing again in 2019. Had 12 kids in program and worked on Science projects with them. Has now switched focus to fitness and doing a boot camp with those in the Boys and Girls Club. Average is 12 - 15 kids.

DA talked about work they will be doing with the Boy's and Girl's club to get data on kids who offend, will share this information to help get kids into program in future.

UPDATE FROM DISTRICT ATTORNEY OFFICE REGARDING NEW JUSTICE PROGRAM:

Program is not a new program, is something the DA's office has been doing for a while, just encompassing under one entity to make diversions more effective.

Idea is to take services that exist already and put them all in one place. Facility will be in the basement of the Orin King building. They are waiting on a signature so the architect can come in and look at building.

New case manager starting in next few weeks, their job will be to consolidate services looking at what the highest needs are for offenders and starting there.

Mark Harris asked about the community partners that are committed to helping: JSS will have to better assess the needs of those in the program prior to knowing what community partners will commit too.

Sheriff Matz asked about compliance with pre charges and if they Sheriffs department will need to adjust anything to accommodate these new DPA's. : JSS will have to look into that more

Paul Eisen asked about Public Safety of letting more offenders on DPA's: 78% of those on DPA's are low level offenders, unsure of recidivism on diversion participants at this time.
