### **MENTAL HEALTH INITIATIVES:**

### **STATUS REPORTS:**

#### **DRUG COURT:**

The numbers for Drug Court and all other Safe Streets programs will be provided.

There will be a graduation in October where it is anticipated that 4 people will graduate.

The mentor group is continuing to be involved in activities and community service with active participants.

The team attended training in May and they are looking at updates to their approach with participants and the program.

#### **SSTOP:**

There is a request for the District Attorney's office to assist in collecting statistics to determine recidivism.

#### **24/7 PROGRAM:**

There is an average of 25 participants in the Drug program and 106 in the alcohol program.

There is a plan to re-evaluate the drug program at the end of the year as it has not been as effective as the alcohol program.

There is also a question of whether unpaid program fees can be included in court costs if there is a conviction.

#### Teen Court

Sarah Whitman is the new Justice Programs Case Manager – this will include Teen Court, DHS Diversion programs, ASP

There is an application for a grant available through the Wisconsin Law Foundation.

#### Good Choices

No new referrals. The program is still only used by Winnebago County and city of Menasha.

#### DISTRICT ATTORNEY DIVERSION PROGRAMS:

The statistics for the various programs are attached. The conditions for each participant are designed to be specific to the individual.

There are pre-charge and post-charge programs.

The mandatory program for overdose cases has a low success rate.

The Justice Services Initiative proposal will be presented to the County Board at a future meeting.

Paul Eisen questioned whether there is a way to calculate how many days in jail are saved by the various diversion programs.

#### STEP UP PROGRAM:

No update available.

#### RE: THINK

There was a Social Connectedness Initiative work shop held in June in connection with POINT.

Members have participated in scans at local festivals to assess compliance with alcohol regulations.

#### DHS Diversion Program

There continues to be an increase in referrals to the program with individuals using internal and external services.
