Good Choices:

*On the agenda for the next meeting the committee will discuss whether or not to continue with the Good Choices Program. Attached to that agenda will be the history and statistics of the program for committee members to feel fully informed before voting.

MISSION STATEMENT:

To create an educational diversion program to give low level offenders an opportunity to reduce the negative implications of poor choices on their future and on the community as a whole.

OBJECTIVE & GOAL STATEMENTS:

- 1) Provide education and awareness in lieu of further police contact.
- 2) Create an opportunity for low level offenders to make one poor choice and not endlessly pay for it.
- 3) Maintain and provide a program that is not only quantifiable but also evidence-based to determine the impact on recidivism.

Participants pay a \$50 fee to view a 4 segment video that requires them to take a quiz after each segment. Participants must get a 100 percent on each section to successfully pass or they are required to pay the \$50 fee again and reattempt the quizzes.

The first video segment is Judge Woldt welcoming and going over the history of how the program started and why. He explains that you must answer all the questions correctly after each video to move on to the next video. He tells them that if they successfully complete this program, there will be no charges referred and they will not have a record on CCAP.

The second video segment is District Attorney Christian Gossett explaining the referral process, the record process you start, the typical process for charges, the typical outcome/penalties and examples of how a person's record has effected them.

The third video segment is Sheriff Matz explaining why they were chosen for this program, why law enforcement backs this program and how records are typically generated if it was not for this program. He talks about the consequences of typical record charges (*retail theft, drugs, dc*) and ends with explaining they will be charged if they do not finish this program.

The fourth video segment is Melissa Pingel, Clerk of Courts who explains CCAP and the process of charges for ordinance and criminal charges. She explains background checks and the inability to clear CCAP. She goes over the potential efforts of a record (whether civil or criminal) on employment, ability to rent, entrances to college, loans and grants, and the public perception (i.e. the public doesn't really understand what happened for someone to get the charge they just see what the charge is etc.)

 - 1. We are working to understand the new alcohol landscape (price, promotion, social and retail access) and how it is impacting the youth.
 - We are also working on a municipal inventory of alcohol related policy, mapping outlet density, and understanding alcohol related calls for service (police) in the area
 - 3. Marijuana is our other drug of focus we are hoping to gather information from youth via key informant interviews to better understand the thoughts and trends of middle and high school aged youth on this subject, so we can target our prevention efforts to match.
