Jail Reintegration (Amy Geffers),

As of 8/19/21

- Participated in Program in 2021(currently enrolled and discharged)- 150
- Requested Narcan (started in June)- 3
- Enrolled in Insurance in 2021- 23
- Medication Assisted treatment referrals in 2021- 30

24/7 Alcohol (Sheriff Matz),

- Offense rate is the same, good participation.
- Ran recidivism reports in 2013 and 2016.
- Recidivism rate is only 8% for alcohol offenses compared to the overall state offenses which is 28%.
- Sheriff department is down 17 positions. They continue to do weekend UAs for Drug Court and 24/7 Drug but it takes a lot longer to do with staff shortages. We need to be mindful of this before assuming the Sheriff's department can take on more.

24/7 Drug (Morgan Hoffman),

- 14 clients in compliance
- 1 clients in non-compliance
- 8 assessment referrals
- 5 assessments completed
