OVERDOSE FATALITY REVIEW AND PUBLIC HEALTH UPDATE

Doug Gieryn provided the annual report from 2018-2019 which includes statistics and recommendations. They are working to implement the recommendations including making narcan available through the health department. The report is attached.

They have been able to obtain funding for years 3 and 4 of the pilot program through the DOJ

Winnebago County Drug and Alcohol Coarlition (WCDAC) has applied for additional funding for the Drug Free Communities grant – which grant was approved in November, 2019.

Doug also provided articles regarding the connection between Public Health and Mass Incarceration. The articles will be sent as an attachment.

STATUS REPORTS:

DRUG COURT:

The numbers for Drug Court have remained consistent – current 30 participants

Phase 1 - 8

Phase 2 - 7

Phase 3 - 7

Phase 4 – 8

There have been a total of 134 graduates. There was a graduation in October and a graduation is planned for January and February 2020.

UW-Oshkosh is presenting a "Humans of Oshkosh" segment and was present at the graduation to film the graduation and interview participants. There will be a book and website focusing on people in recovery.

The drug court participants will continue community outreach including speaking at Oshkosh high schools.

The team is looking at revising their forms and any modifications will be presented to the Safe Streets committee for final approval.

SSTOP:

The program has been able to link with the DA's office IS which can interface with CCAP to determine if participants have new court activity. A report is generated each week.

24/7 PROGRAM:

There is an average of 15 participants in the Drug program and 106 in the alcohol program.

Teen Court

There are 12 active participants. There has been an increase in referrals since school began this fall.
