#### DRUG COURT:

The numbers for Drug Court and all other Safe Streets programs were sent by Carol Morack after the last meeting. The staffings and court proceedings are being conducted virtual. The mentor groups and UA's are being conducted in-person.

#### 24/7 PROGRAM:

Due to the health crisis individuals are engaged in the programs longer. The numbers as of October 23, 2020:

130 Alcohol Participants Alcohol-200 total participants Jan 1 2020 – Sept 30 2020

Today 29 Drug Participants Drug – 53 total Participants Jan 1 2020 – Sept 30 2020

Sheriff Matz will be providing a more in-depth review of both programs after Dec of 2020. "The last cumulative study was 2011 – 2016 for alcohol. At that time we had 1062 participants with a 8% recidivism rate for OWI related offenses and 23% re-offense rate of 23%."

#### DISTRICT ATTORNEY DIVERSION PROGRAMS:

The DA's office provided numbers as of October 16, 2020.

At the time there were 300 referrals or active participants in the programs. There were 43 pending offers and 50 possible revocations.

#### STEP UP PROGRAM:

Chee Vang sent an e-mail prior to the meeting as he was unable to attend. He advised "Step Up has nothing new to add on hold until this clears up".

## Teen Court

The following was submitted by email prior to the meeting:

12 active participants (since the last meeting we successfully completed 10 participants) 4 volunteer attorneys (hoping to recruit more-I made some awesome "Winnebago County Teen Court" shirts for our Attorneys to wear for the hearings.

New Judges- we have had new "judges" participate in TC and they have been amazing- we are very grateful for their support to keep TC running.

Teen Court Poster contest- winner will get a 30\$ gift card to place of their choice- and community services hour (offered to all TC participants- ongoing)

We are running in person hearing at the Winnebago County Sheriffs Dept (previous at the court house) which has been working very well for us. I have limited the number of cases and jury members each month so we can provide social distances and everyone wears a mask. I am seeing a consistent flow of referrals to TC. Despite COVID, parents still want their youth to participate.

The majority of my referrals are for Vape/Tobacco offenses
