## **CALL TO ORDER**

## **APPROVE AGENDA**

Motion to approve by Bill Topel and seconded by Adam Dorn. The motion carried unanimously.

## **NEW BUSINESS**

Status update regarding Rayfe J. Paulick and placement options.

Angela Serwa indicated Mr. Paulick has no known limitations to live independently. He will not be referred to the ADRC for any functional screen as of the middle of May 2022. We would have already heard if there were concerns regarding his placement options. Angela did clarify he is a serious child sex offender.

Mary-Anne Mueller, indicated the open space in a trailer home has been filled by another 980 resident based on a judge's ruling. This means there are no openings in the current trailer.

The options considered in the past for placement have been to work with a state vendor who serves as a landlord or create a county owned residential option. Last week the Winnebago County Board of Supervisors authorized a capital project and funding of over \$1,000,000 to design and construct a residential facility for released 980 sex offenders. Mike Elder is proceeding accordingly with the preparation for the design and construction of a county owned residential option.

Our next step is to go to the City of Oshkosh to get approval for construction of this building. At the same time we are pursuing the new construction we will be looking for other housing options for Mr. Paulick.

At this time no one has contacted Angela Serwa regarding housing options that would be available for placement of 980 offenders. If she is contacted she will forward that information to Mary-Anne Mueller. She will forward the current landlord list of vendors that work with DHS for supervised release housing.

Mary-Anne Mueller requested Angela Serwa provide information about the length of Mr. Paulick's detention at Sandridge, the amount of time he served and when the crime occurred.

Bill Topel made a few statements.

First, Bill has not received the notice which should be sent to the Director of the 51.42 Board. He was assured he would be receiving these notices. He has yet to receive an official notice about Mr. Paulick as well as another individual. Bill requested Angela Serwa and Kristin Kiel follow-up on why he is not received these notices.

Angela will follow-up with the Records Department and determine how those notices are coming out.

Second, a member of WI Dept. of Health Services made misrepresentations of fact in court this past week. These misrepresentations relate to what happens with Medicaid, functional screens, and if someone is enrolled in family care. These misrepresentations were clarified in our last meeting. Bill indicated if these misrepresentations happen again he will pursue reporting to the ethics board or file a complaint with DHS.
