CALL TO ORDER

APPROVE AGENDA

NEW BUSINESS

Status update regarding Rayfe J. Paulick and placement options.

The deadline to identify an appropriate residential option in Winnebago County while Mr. Paulick is on supervised release is August 24, 2022. This committee has met four times since we were notified of Mr Paulick coming to Winnebago County. To find housing we reached out to realtors. This has been unsuccessful to date. We contacted properties identified by DHS as potential landlords. Six potential landlords responded. There were no matches which meet the counties requirements.

The county continues to move forward with the construction of residential facilities. Winnebago County Board approved over \$1,000,000 to construct a residential facility. Winnebago County staff met with the City of Oshkosh to review plans because it is in their jurisdiction. They indicated we needed to hire an architect to finalize plans to be presented to the city. The architects are in the process of submitting the final plans. Yesterday Corporation Counsel Mary-Anne Mueller, Attorney Mann and Mr. Elder went to court to report on the current status.

Winnebago County has found an appropriate residential option. It is on the W 800 block of County Road Y in Oshkosh. Winnebago County is the landlord and is committed to entering into a lease for a fair amount with the state. Final construction needs to happen on that site. Mr. Elder indicates that could take up to a year. Captain Christie is supportive of the location.

Corporation Counsel Mary-Anne Mueller moves to submit a report identifying the W 800 block of County Road Y in Oshkosh as the appropriate residential option. Seconded by Mike Elder.

Kristin Kiel asked if Mr. Paulick would need to wait a year for placement. Mary-Anne requested to hear from Executive Doemel. He indicated it might not be a year if a space opens up in the current mobile home. Mary-Anne asked Kristin if she had any new information about the status of the individual currently in the mobile home with the initials of CG. Kristin indicated there is nothing on the schedule for any court action to have him discharged from supervised release at this time. The average amount of time someone is on supervised release is 30 months.

The motion passed unanimously.

A letter will be sent out to meet the statutory deadline.

The committee plans to meet again October 20, 2022 at 1:00 pm for a status update.

There was no further discussion of this item.
