- 1. Call to Order: P. O'Brien called the meeting to order at 9:01 a.m.
- 2. <u>Approve Agenda:</u> Motion to approve the January 4, 2017 agenda, made by K. Robl and seconded by S. Locke. Motion carried 7-0.
- 3. Public Comments on Agenda Items: None.
- 4. <u>Announcements/Communications:</u> J. Rabe provided Solid Waste Management Board (SWMB) members with informational packets for the Wisconsin Integrated Resource Management Conference to be held at The Osthoff Resort in Elkhart Lake, WI from March 1-3, 2017. Discounted rates are available until February 8, 2017 for room reservations and February 15, 2017 for conference registration.
- 5. <u>Approval of Minutes December 21, 2016 Open Session:</u> Motion to approve the December 21, 2016 open session minutes, made by K. Robl and seconded by G. Konrad. Motion carried 7-0.
- 6. <u>Discussion Transfer Station Tipping Floor Replacement Project Update:</u> K. Pernsteiner presented the Transfer Station (TS) Tipping Floor Replacement Project (SW06-16) Update to the SWMB. The TS Tipping Floor Replacement Project was awarded to Miron Construction at

the October 19, 2016 meeting; the work took place October 29, 2016 – November 18, 2016. K. Pernsteiner reported that the TS Tipping Floor Replacement Budget Summary is as follows:

K. Pernsteiner indicated that the Project was completed on time and Staff are pleased with the work.

Discussion ensued amongst the SWMB.

7. <u>Discussion – Transfer Station Compactor Project Update:</u> K. Pernsteiner presented the TS Compactor Project Update to the SWMB. K. Pernsteiner explained that TS Compactor Project SW03-16 (for 1 MSW and 1 SSR Compactor) was awarded at the June 1, 2016 meeting and TS Compactor Project SW07-16 (for 2<sup>nd</sup> MSW/C&D Compactor) was awarded at the July 19, 2016 meeting; both projects were awarded to Immel Construction. The work for SW03-16 took place November 7, 2016 – December 1, 2016 and work for SW07-16 occurred from December 12 – 16, 2017. K. Pernsteiner stated that the projects were completed on time and Staff are pleased with the work. K. Pernsteiner presented the following Project Budget Summaries to the SWMB:

K. Pernsteiner indicated that the first compactor trailer doors did not fit on the compactor snout properly. A modification was made to the door design but it caused a slight delay in manufacturing the new compactor trailers. Kreilkamp Trucking (contracted hauler) provided temporary compactor trailers to use during this time, which helped keep TS operations running smoothly. As of December 31, 2016, all 5 new compactor trailers were available for use at the TS.

K. Pernsteiner presented compacted material hauling tonnages and cost summaries to the SWMB. Based on December 2016 data, Staff anticipate a savings of ~\$50,000/year on SSR hauling and ~\$200,000/year on MSW hauling.

Discussion ensued amongst the SWMB.

- 8. <u>Discussion Sludge Site Operations Update</u>: J. Rabe presented the Sludge Site Operations Update to the SWMB. J. Rabe reported that:
  - Sludge Site Operations were last discussed at the December 21, 2016 meeting. Odor issues caused by frozen, temporary landfill gas (LFG) lines were reported.
  - On December 22, 2016, Foth Infrastructure & Environment (Foth) worked with Riverview Construction (Riverview) to thaw frozen sections of the temporary LFG lines; vacuum was also restored to sump risers; these corrections are expected to help mitigate odors.
  - Foth identified an area near the final fill section (east slope) that needed more fly ash; Riverview placed an additional 16 loads of Weston fly ash to seal off this area, which should help reduce odors.
  - Wood chips are being used to help prevent the temporary LFG lines from re-freezing.
  - The Sludge Site will likely require day-to-day monitoring/adjustments for odors until the final cover construction project is completed.

Discussion ensued amongst the SWMB.
