- 1. Call to Order: K. Robl called the meeting to order at 9:00 a.m.
- 2. <u>Approve Agenda:</u> Motion to approve the December 6, 2017 agenda, made by J. Finch and seconded by S. Locke. Motion carried 7-0.
- 3. Public Comments on Agenda Items: None.
- 4. <u>Announcements/Communications:</u> J. Rabe asked the Solid Waste Management Board (SWMB) of their availability on January 3, 2018. The consensus of the SWMB members was to cancel the January 3, 2018 meeting.
- 5. <u>Approval of Minutes November 15, 2017 Open and Closed Session:</u> Motion to approve the November 15, 2017 open and closed session minutes, made by J. Finch and seconded by G. Konrad. Motion carried 6-0. D. Nelson abstained.

- 6. <u>Discussion/Action Award Tandem Axle Chassis with Hooklift & Automatic Tarper:</u> J. Rabe explained to the SWMB that the Tandem Axle Chassis with Hooklift & Automatic Tarper capital purchase will allow us to self-perform the pulls and unloads of our onsite rolloff boxes. J. Rabe explained to the SWMB that up until this point we have subcontracted with Van's Waste to provide these services. J. Rabe further explained there is an increased need to empty these rolloff boxes more frequently with the site modifications at the Residential Drop-off area and with the compactors at the Transfer Station.
  - K. Pernsteiner explained that a Request for Proposals was prepared and five (5) proposals were received on November 28, 2017. K. Pernsteiner explained that the 2017 Budget amount for the rolloff box truck is \$250,000. K. Pernsteiner presented the five (5) proposals to the SWMB as follows:

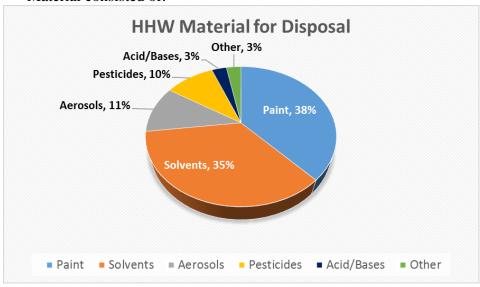
Discussion ensued amongst the SWMB.

- 7. <u>Discussion 2017 Household Hazardous Waste program Report:</u> K. Hutter presented the following 2017 Household Hazardous Waste (HHW) Program Report to the SWMB. Summary
  - Season: May 10 October 28, open 9 a.m. noon on select Wednesdays and Saturdays (23 total operational days)
  - Operations: Staffing and disposal handled by Brown County Hazardous Material Recovery (BC HMR).

## **Program Statistics**

- Users: 879 customers (up from 852 users in 2016)
- 6 Winnebago County (WC) customers direct to Brown County (BC) with 1,244 lbs.
- Total collected 42,587 lbs. (down from 45,481 lbs. in 2016)
- Average 48.45 lbs. per user (decrease from 2016, 53.38 lbs.)
- 5,222 lbs. of material made available to the public in the product exchange room; ~\$5,640 savings in disposal costs (decrease from 2016 5,739 lbs./\$6,083 savings)
- Material consisted of:

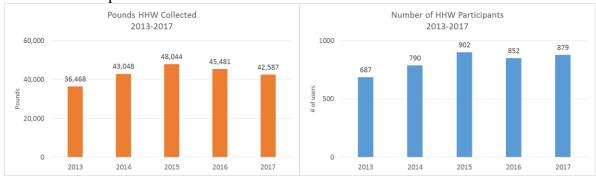
- Are the hours of operation convenient to you?
  - Yes 94%, No 6%; primarily more hours and later hours requested. One request for year round; one request for opening in April.
- What city or community did you travel from?
  - Oshkosh 42%
  - Neenah 28%
  - Menasha 6%
  - Village/Town of Winneconne, Village of Fox Crossing 4% each.
  - Town of Oshkosh, Town of Algoma 3% each.

- How did you hear about this program?
  - Return customer 31%
  - Online/website 18%
  - Flyer, Landfill/Recycling Office, Community Newsletter/Municipal Office 13% each

- Are you aware of the Product Exchange Room?
  - Yes 55%, No 45%

- Was there anything that you wanted to drop off here but couldn't? Responses = 82 "yes", 450 "no", 212 no response.
  - Yes latex paint 43%
  - Yes antifreeze 19%
  - Yes automotive batteries 6%
  - Yes bulbs 12%
  - Yes motor oil 10%
  - Yes other 10% (appliances, e-waste, solid waste)

Per comment cards - some users weren't initially aware most of the additional materials could be taken across the street; others didn't want to pay for disposal.

Latex paint is not accepted because it can be disposed in the regular trash once it is dried out. Residents with latex paint are given instructions as to how to properly dispose of it. Disposal of latex paint through the HHW program is cost prohibitive; 2017 estimate for BC HMR to provide latex paint disposal at WC HHW is \$230-\$260 per cu. yd. box (~100 gallon size pails).

  - Work began on September 28, 2017 and substantial completion was reached on December 3, 2017
  - Punchlist walk-through completed on December 1, 2017
  - Remaining items for Advance Construction (Advance):
    - Portable toilet shelter: December 2017 installation
    - Fishing pier: January 2018 installation
    - Tree plantings: Spring 2018
  - Cross Access Agreement signed/recorded complete
  - J. Rabe updated the SWMB on the Snell Road Final Cover Repairs as follows:
    - Riverview started repair work on October 17, 2017 and completed on November 8, 2017
    - Actual cost was ~\$125,000 vs. estimate of ~\$138,000
    - Foth Infrastructure & Environment (Foth) prepared/submitted a Notice of Noncompliance (NON) letter report to WI Department of Natural Resources (WDNR) on December 5, 2017; hope to be back in compliance by December 31, 2017
  - J. Rabe updated the SWMB on the Sludge Site Final Cover Project as follows:
    - Substantial completion reached holding \$50,000 in retainage to ensure that vegetation is fully established in Spring 2018
    - Documentation report submitted to WDNR on October 20, 2017; hope to receive WDNR approval by December 31, 2017
  - J. Rabe updated the SWMB on the Residential Drop-off Area Modification Project as follows:
    - Substantial completion reached holding ~\$19,700 in retainage to ensure that vegetation is fully established in Spring 2018
    - Waiting on as-built report from Foth (not submitted to WDNR)
  - J. Rabe reviewed the Capital Project Summary with the SWMB as follows:
