Old Business: Greg Brittnacher has taken over Wendy Conger's position and Susan Giese, an Army veteran has been hired to replace Greg. She starts 2/26/18. She will be formally introduced at next months VSC meeting.

The office currently has an intern who is doing her Master's Degree clinical. Having her in the office, especially now that the office is short staffed, shows just how much an extra person is

needed. She has also been doing some intense case management with very good results and many ancillary benefits for clients. We will have another intern starting in September 2018 and she is working on her Bachelor's degree in Human Services.

Jim Harsh from the Green Bay Vet Center is taking over a Director position in the U.P. A new counselor has been hired and is starting the 3rdd week in April. Wants to have a permanent presence in the office on Tuesday, Thursday and every other Friday. Would like to have late Tuesday hours until 7:00. Working with maintenance to see how this will work with building being closed, etc. Also if an office staff would have to be here during those hours.

With recent shooting at VA PTSD Center in CA, Joe discussed letting people down easy when we have to cut them off form VSC funds. The office has obtained some desk sirens for each person. Staff is concerned for their own safety with all the recent shootings.

New Business: The VORP bill will be coming up for a vote shortly. The federal CVSO funding bill is having a hard time finding support from someone on the Veterans Committee. The check for the CVSO Grant in the amount of \$13,000 has received last week. Per Finance all funds put back to 2017.
