 weeks and filled.
- Winneconne outreach is going well and we will start an Omro Outreach at the Omro Community Center on March 15 – Kevin & Lydia will be there along with Ken Corry from Vet Center.
- The \$14,300 Grant from the state has been deposited.
- Prisons are open to visitors again, so Jeff will begin his outreach within the prisons again.

New Business:

- Tom is still pushing the CVSO Act. It was amended into the Honoring Our PACT Law Act. Eight State Representatives voted on this and three voted yes, five voted no. Tom Snider urges people to call Oshkosh office asking the Senators to vote. On a side note, the CVSO ACT still in in the committee. Jeff confirmed that Allegiant Airlines is offering free checked baggage for veterans with a copy of their DD214; this was a question brought to the table last month by Roy Rogers.
- This is Lucy Burr's last meeting with the VSC. Peggy Schumacher has agreed to fill Lucy's position. Letters have been drafted and reviewed by Peggy for her appointment by the County Executive.
