A new Benefit Specialist was tentatively approved for the 4th quarter of 2019. Even though starting at the end of year, will be in place for the 2020 budget.

Joe spoke on payment procedure changes to the "care of veteran graves" line item. Because of the changes in 2019, he believes that this account will be down \$5000.00 by the 2020 budget. Joe also explained why the donation line item is \$0. The office can only utilize the funds over the amount budgeted. Projecting \$0, will allow the office to use all the funds donated, which is the intention of those donating.

New Business: The federal legislation for funding CVSO's is not gaining ground. Discussion on County building security.
