### **Implementation Updates**

Implementation updates and projects for 2020

- Confirmed projects:
  - Water quality monitoring program Winnebago Waterways
  - Terrell's Island and Samers Bay Restoration (partner project; will be seeking additional funding)
    - Public outreach effort in middle of March (holding public meetings; WDNR will lead)
    - Fox-Wolf serving as fiscal agent
    - Lead partners are WDNR, Winnebago County, and BDMCC
  - o AIS WDNR Pilot Program
  - "Climate Crisis" project Steering Committee
  - o AIS Clean Boat, Clean Waters Program
  - o GLRI Pipe Creek Project
  - Other LMP implementation:
    - Scoring and prioritizing habitat projects
    - Community Engagement
    - Plan Adoption
    - Tracking system set-up
- Projects in development:
  - Stuyvenberg Island Protection Project (Old Indian Point, Lake Poygan)
- Projects waiting on funding response:
  - "Real Time, Low Cost, Plug and Play 'Internet of Things' HAB Detection System for Local Water Quality Managers" Technical Advisory Committee (partner project, will be serving on committee)
  - UW-Oshkosh SIRT NSF Project (partner project; will be assisting)
- Recent funding decisions
  - WDNR funding was awarded for the Evaluation of Breakwalls study with UW-Oshkosh
  - WDNR Funding was not awarded for the Sunset Bay APM project

### Brief updates from around the system

- Fond du Lac County
  - 2 new conservation technicians: Brad Murry & Sage
  - NRCS working with Pipe Creek landowner to do a significant stream restoration
    - Likely will apply for funding for that project; exploring funding options
    - 2021 Project at the earliest based on available funding
- Calumet County
  - Will be holding a private well testing program in Stockbridge; will include many shoreline properties (April)
  - Manure spreading on snow has been an issue
  - Submitted lake protection grants for Cal Man Lakes for ag conservation practices in watershed; will compliment new demo farm network
- Winnebago County
  - Samers Bay/Terrell's Island public outreach
  - 3 to 4 shoreline projects going in next week; Lake Winnebago, Poygan
  - Breakwall construction in Lake Winneconne will begin next week
  - Cost-share of 70% up to \$500 for rain gardens; partnership with rotary club
- Waushara County

- Review of codes
- Going to court with farmer in violation with 151; manure is overflowing banks and has entered waters of the state; lack of cooperation from landowner has led to this going to court
- Conservation field days at Camp L. coming up in March. 5<sup>th</sup> graders two-day event.
- Central Sands Groundwater Collaborative
  - Sending letters of support for various bills that have gone before legislature.

#### o WDNR

- Sturgeon Spearing season
- Oversubscribed by a factor of 2 for WDNR planning grants; as a results not all projects were funded
- Currently reviewing protection grants
