RESOLUTION:

Authorize the Winnebago County Clerk to Publish a Notice of Referendum Regarding the Enactment of Proposed Legislation to Support the Passage of an Amendment to the United States Constitution to Reclaim Democracy from the Expansion of Corporate Personhood Rights and the Corrupting Influence of Unlimited Political Contributions and Spending

TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:

WHEREAS, the group "United to Amend" is seeking support from "We the People" of Winnebago County to reclaim democracy from the expansion of corporate personhood rights and the corrupting influence of unlimited political contributions and spending by placing an advisory referendum on the ballot during the November 2020 general election; and

WHEREAS, § 59.52(25), Wis Stats, allows for a county board to conduct a county-wide referendum for advisory purposes. A county-wide advisory referendum on the issue of whether or not to limit contributions by corporations, unions, and other artificial entities would provide guidance to the state legislature as to the will of the Winnebago County electorate on this issue. This resolution seeks authorization to conduct such a county-wide advisory referendum.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes Winnebago County to conduct a county-wide advisory referendum to appear on ballots during the November 2020 general election; and that a concise statement of the guestion be given and shall read as follows:

 <u>Question</u>: Should the state legislature enact proposed legislation to support passage of an amendment to the United States Constitution that seeks to reclaim democracy from the expansion of corporate personhood rights and the corrupting influence of unlimited political contributions and spending?

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby directs the Winnebago County Corporation Counsel to prepare a Notice of Referendum to be published by the Winnebago County Clerk in accordance with statutory requirements.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that this Resolution and the referendum shall be filed with the Winnebago County Clerk no later than 70 days prior to the election at which the question will appear on the ballot.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby directs the Winnebago County Clerk to forward a copy of this Resolution to the Winnebago County Corporation Counsel and the Winnebago County Executive in accordance with statutory requirements.
