21	(2) PURPOSE & INTENT: Following due consideration of the recreational value to connect trail opportunities and		
22	weighted against possible dangers, public health, liability aspects, terrain involved and traffic density, these routes have

24	(3) AUTHORITY: The provisions of this Ordinance are adopted by the Winnebago County Board of Supervisors

71	that Winnebago County would have passed the other provisions of this Ordinance regardless of whether or not one		
72	or more provisions may be declared invalid. If any provision of this Ordinance or the application to any individual or		
73	circumstance is held invalid, the remainder of the Ordinance and the application of such provisions to other		
74	individual circumstances shall not be deemed affected.
