Claim from Jason Davis for damage to his vehicle's windshield caused by debris

falling out of the back of a Winnebago County truck.

This claim will be presented to the County Board at their July 16, 2019 meeting.

To Whom It Concerns,

I am writing to explain an incident that occurred that caused damage to my car. On June 4th at approximately 8:20 am I was driving on Highway 41 to work. I was in the center lane with a Winnebago County truck in front of me. The back of the truck said "Stay Back 50 feet" or something similar. This truck had a rust colored bed with the writing in red. The back of the truck, to the best I can explain was rust colored "box" used to carry rock or rubble. While driving behind the truck some debris fell out of the back and bounced up and hit the outter edge of my windshield. In the black area on the very bottom passenger side. I got out of the center lane and moved to the left lane. At this point we were approximately passing over Jackson Street/Hwy 76. I did not have knowledge of the damage to my windshield at this time. I passed by the front of the truck which I believe was white with the county logo on the driver said door with the word "service" under the logo. When I reached my place of employment I noticed where the rock had struck my windshield. I would look into it more after work. When I returned to my car at approximately 4:00 pm the chip/hole had grown to 12"-18" across the passenger side windshield from the heat on the windshield and inside the car that day. I called Tri City Glass in Appleton for an estimate on the windshield at approximately 4:30 pm on June 4th. They sent me an estimate via email later that day which I have included with this letter. I spoke with my insurance company and was told to reach out to the company that owns the truck which the rock fell out of. Since the date of the incident the crack has grown to half of the windshield. I have submitted pictures to go along with this letter as well.
